India and Bangladesh resolved on Tuesday to further strengthen their bilateral ties, including trade, water-sharing, connectivity and nuclear energy with Prime Minister Narendra Modi noting Bangladesh is the biggest trade and development partner in the region.

He also called for jointly facing terrorist and fundamentalist forces that threaten to attack mutual trust between the two nations.

The Prime Minister made these observations after holding talks with visiting Bangladesh Prime Minister Sheikh Hasina.

The two countries inked seven pacts, including one on sharing of waters of Kushiyara River, which will benefit the regions of southern Assam and Bangladesh's Sylhet region. Hasina urged early conclusion of the Teesta water sharing agreement.

The interim water sharing

agreement for Kushiyara river is the first such pact since the signing of the Ganga water treaty in 1996. The Ganga water pact for a period of 30 years was signed by then Prime Minister HD Deve Gowda and Hasina.

On his talks with the visiting dignitary, Modi said, "Today we also stressed on cooperation against terrorism

and fundamentalism. To keep the spirit of 1971 alive, it is also very necessary that we face such forces together, who want to attack our mutual trust."

On water sharing pacts, the Indian Prime Minister said 54 rivers pass through the borders of India and Bangladesh and are linked to the livelihood of the people of both the countries for cen-

turies.

"I recall that the two countries have resolved many issues in the spirit of friendship and cooperation. We hope that all outstanding issues, including Teesta water sharing agreement, will be concluded as an early date," Hasina said at a joint media interaction with Modi at the Hyderabad House here.

Liquor scam: ED
raids across IndiaLike CBI, ED too won't
find any proof: Sisodia

The Enforcement Directorate on Tuesday conducted nationwide searches in connection with a money laundering probe linked to the alleged excise scam in Delhi in which Deputy CM Manish Sisodia is the prime accused.

Besides Sisodia, some bureaucrats have also been named as accused in the alleged scam related to the now scrapped Delhi excise policy.

The agency searched about 30 premises in Delhi, Telangana, Maharashtra, Haryana, Uttar Pradesh and

Karnataka and the operation covered private individuals named in the case, officials said. They said Tuesday's search operation did not include premises linked to Sisodia or any other Government servant named in the case.

The ED initiated a probe in the case under the Prevention of Money Laundering Act (PMLA) after taking cognisance of a CBI FIR that has named Sisodia and 14 others as accused in the case. Reacting to the raids, Sisodia said he has nothing to hide and did his job honestly. "First the CBI conducted raids, they found nothing. Now, the ED is conducting raids, they too won't find anything," he said.

Bihar Chief Minister Nitish Kumar on Tuesday continued with his efforts to bring together all Opposition parties under one umbrella and met several leaders, including those from the Left, Delhi Chief Minister Arvind Kejriwal and Samajwadi Party patriarch Mulayam Singh Yadav.

Nitish held a meeting with former Congress chief Rahul Gandhi a day earlier.

The JD(U) leader who quit the NDA fold to join the RJD, the Congress and others to lead

a grand alliance Government in Bihar last month, also called on INLD supremo OP Chautala and JDS leader HD Kumaraswamy amid speculation that Nitish may also want to bring together Janata parivar to take on the Narendra Modi juggernaut in the 2024 polls.

Soon after the Nitish-Chautala meeting, it was also announced that the Bihar CM and his deputy RJD leader Tejashwi Yadav, NCP supremo Sharad Pawar, National Conference leader Farooq Abdullah will attend the INLD's September 25 rally in Haryana.

Chautala invited Nitish to attend the rally to mark the birthday of former Prime Minister Devi Lal.

PM to introduce cheetahs

Seventy-five years after India's last cheetah died in 1947, Prime Minister Narendra Modi will introduce five of the world's fastest animals in Madhya Pradesh's Kuno National Park on September 17, which also happens to be the PM's birthday. Madhya Pradesh Chief Minister Shivraj Singh Chouhan confirmed the development on Tuesday.

All hotels and restaurants around Kuno have been booked by the district administration from September 14 to 20. Cheetahs would reach Kuno from Namibia, a day before Modi's arrival.

The five cheetahs will be brought from Windhoek in Namibia to Jaipur and from there they will be shifted through airways to Palpur in Kuno. Two helpads have been developed inside the park.

Nothing new in the report of committee on land laws- Rawat

Congress leader and former MLA of Kedarnath Manoj Rawat has termed the report submitted by the high powered committee on land laws as old wine in a new bottle and a desperate attempt by the State government to divert the attention of the people of the State from the burning issues. He said that the Pushkar Singh Dhami government had made lofty claims when it constituted the committee but there is nothing new the recommendations of the committee except that it has advocated that the authority for approval of purchase of land by outsiders should be taken away from the district magistrates (DMs) and given to the State administration. He claimed that open loot of the land of the State started with the passage of the amendments in section 143 (A) and 154 (2) of Uttarakhand (Uttar Pradesh) Zamin-dari Abolition and Land Reforms Act- 1950 on December 2018 in Vidhan Sabha. These amendments allowed outsiders to buy as much land



they wish in the name of industrialisation (industry, tourism, education and health). Rawat questioned whether the committee had sought a report from the DMs on the approvals given by them on the applications for purchase of the land and if it has; its report should be made public. He claimed that properties worth hundreds of crores of rupees were sold to outsiders in the last four years. Rawat said that the government should disclose the amount of investment that came to the State in these four

years after gifting precious land to the outsiders.

The Congress leader said that section -118 of Tenancy Act is enforced in Himachal Pradesh according to which an investor can become a partner but the land remains with the domicile resident of the State. The people need to know about any such recommendation made by the committee, he said. Rawat said that since the committee has accepted that the land purchased by outsiders for the purpose of agriculture and horticulture is being misused for constructing resorts and private bungalows, the government should take back the land given to them. The former MLA demanded that as per the recommendation of the committee the State government should start the process of land settlement in Uttarakhand as it has not happened from the last 60-65 years.

Give suggestions instead of playing politics on land laws recommendations- BJP

Responding to the statement made by the leader of opposition Yashpal Arya, the Bharatiya Janata Party has termed his views irresponsible and motivated by politics. Arya had alleged that the BJP government had favoured its people in sale of lands during the past four years and that the committee and its recommendations are more of a diversion.

The BJP State president Mahendra Bhatt said that Arya has a long legislative experience and has been connected with public issues. However, he is linking the recommendations of the committee with politics instead of contributing constructively. Bhatt said, "The demand for land laws in Uttarakhand has been raised for many years and the BJP had included it in its election manifesto. The State has its doors open for investors and development works but the misuse of land will not be allowed. Provision has been made for this purpose. While there will be a check on un-

controlled land transactions, employment generation will also be ensured. Further, illegal possessions will also be prevented." He further consultations were held with all sections before the recommendations of the committee.

The BJP State spokesman Ravinder Jugran said that the government will study the recommendations made by the committee and take a decision according to the vision which led to creation of Uttarakhand. On the lines of Himachal Pradesh, in the interests of the State's people and to encourage investment the government may soon take a decision on this. He said that for the past five decades the demand for land consolidation is being raised strongly in Uttarakhand. Chief minister Pushkar Singh Dhami has taken a step towards fulfilling this demand with the State government taking this issue seriously, he added.

Vidhan Sabha should remain free from pollution of corruption- Rawat

Comparing the Vidhan Sabha with Gangotri from where the holy Ganga emerges, former chief minister Trivendra Singh Rawat has said that there is an urgent need to keep this Gangotri of political and legislative power free from the pollution of corruption. "There is a hope for keeping the Ganga clean as long as Gangotri is clean and similar is the case with the Vidhan Sabha also which is the law making body of our State," said the former chief minister while talking with The Pioneer on Tuesday.

On the allegation of corruption and appointments of favour made in the Vidhan Sabha, the former CM opined that the crime of those who made these appointments is many times more than those who got these jobs. He said that the file for making appointments in Vidhan Sabha

was brought before him when he was chief minister. Rawat said that he made a noting on the file that the appointments should be done in a transparent manner and should be done by the public service commission. It is pertinent to mention here that the ad-hoc appointment of 72 employees was made in the Uttarakhand Vidhan Sabha after Trivendra Singh Rawat was removed from the position of the CM of the State.

Meanwhile the expert committee constituted by the speaker Ritu Khanduri to investigate the allegations of illegal appointments and promotions in the Vidhan Sabha has started its work. The committee headed by former principal secretary Dilip Kumar Kotia has been asked to submit its report in a period of one month. The other two



members of the committee are Surendra Singh Rawat and AS Nayal.

The expert committee would investigate the appointments made in the Vidhan Sabha in two phases, in the first phase the appointments done from the year 2012 till date would be investigated and in the second the appointments from the year 2000 to 2011 would be checked.

Transport Dept to conduct RTA meeting after three years

The Transport department is gearing up to conduct a regional transport authority (RTA) meeting of the Garhwal division after three years to take decisions on various matters associated with local public transport. The regional transport officer (administration) of Dehradun and secretary of RTA Dinesh Chandra Pathoi informed that the department will take the decision on issuing new permits for buses, auto rickshaws and Vikrams on several routes in Dehradun and Haridwar. Besides this, Dehradun RTO is also planning to commence the operation of Tata Magic on several routes that fall in the internal areas of the city. The members of RTA will

also discuss increasing the number of private buses on the Dehradun-Selaqui route besides issuing new permits for buses to Maldevta from Raipur Road and Parade Ground. The department is also considering increasing the operation of buses in the Kalsi area and from Parade Ground to the Shimla Bypass route too, informed Pathoi. Besides this, some other proposals would also be considered in the RTA meeting. The meeting has been deferred six times in the past three years due to certain reasons but now the department has started preparations for the meeting which is scheduled to be held this month, stated Pathoi.

Miscreants loot cash and jewellery at gunpoint in Jhabreda

Unidentified criminals committed an armed robbery in the home of a contractor in Jhabreda police station area late on Monday night. The criminals robbed Rs 5.70 lakh and jewellery from the home. The police reached the site on being informed and combed the area throughout the night but could not find the culprits. The police have registered a case and started investigation in the armed robbery.

ident of Fakkarhedi village of Jhabreda police station area recently built a home outside the village. On Monday night around 11:30 PM, three men entered his house by climbing the wall and threatened him with a pistol. After this, the miscreants opened the cupboard to steal Rs 5.70 lakh cash and jewellery before fleeing.

Jhabreda police station officer Sanjeev Thapliyal said that a case has been registered in the matter and the miscreants will be caught soon.

12 new dengue patients reported in Dehradun

The Dehradun district is increasingly becoming a hotspot of the vector borne disease dengue. On Tuesday the State health authorities reported 12 new patients of dengue in the district. With it the number of dengue patients in the district increased to 67 in this season.

The district vector borne diseases officer of Dehradun,



Subhash Joshi said that three female and nine male patients of the disease were reported on the day. He said that these patients of the disease are admitted in different hospitals of the city and the condition of all patients is stable. Dengue is a viral infection spread by the

mosquito Aedes Aegypti popularly known as Tiger Mosquito. The symptoms of the disease are persistent high fever, rashes, headache and pain in the joints. In the acute cases the platelets number decreases drastically which may prove fatal for the patient. In Uttarakhand the disease is more prevalent in Dehradun, Haridwar, Nainital and Udham Singh Nagar districts.

Ways to prevent Dengue

- 1 Don't allow water to collect in and near houses.
- 2 Regularly decant fridges, coolers, pots or cans.
- 3 Spread kerosene or any other oil on the small water bodies to destroy the larvae of the Aedes mosquito.
- 4 Inform the district authorities for fogging to kill mosquitoes.
- 5 Since Aedes strikes during day time and flies near ground level so wear full sleeved clothes at work places.
- 6 Immediately seek medical advice when someone develops fever.

Man nabbed for killing friend not returning Rs 5K

The police have solved the murder of Ankit Kumar who was allegedly killed by his friend Sunil Mishra. The police informed revealed that both the men used to work at the same place in SIIDCUL. During interrogation, the accused said that he ended up stabbing Ankit after an argument when the latter was unable to return Rs 5,000 he had borrowed. CO (Sadar) Bahadur Singh Chauhan said that Ankit was stabbed fatally on the night of June 13 at Labour Chowk, SIIDCUL. The police registered a case based on a complaint by the victim's family member and began investigation. The police were able to identify the main suspect by checking CCTV footage. The CO said that during interro-



gation, the accused Sunil said that he had lent Rs 5,000 to Ankit in May. Ankit had promised to return the money after a month but was not doing so despite being asked for it repeatedly. Fol-

lowing a fight on the issue, Sunil stabbed Ankit and fled from the scene. The police presented the accused in court from where he was sent to jail.

Says the investors have given a new dimension to the State in industrial sector

Chief Minister Pushkar Singh Dhami has said that production in projects worth Rs 15,000 crore has started in the industrial units of the State established in the State from January 2020 till date which is a major feat considering the pandemic of Covid 19.

He said work on a fast pace is going on for construction of good roads, rail and air connectivity essential for attracting industries.

Speaking on the occasion the Industries minister Chandan Ram Dass said that the positive effects of the investors' meet held in the State under the leadership of Prime Minister Narendra Modi are clearly visible in Uttarakhand. He said that small and medium industrial units should be promoted in the mountainous areas of the state.

72-year-old man kills wife with bat over property dispute

A 72-year-old man Ram Singh Thakur allegedly killed his 53-year-old wife Usha Devi with a bat over property dispute in Dehradun. The accused, who is also suffering from cancer, had allegedly killed his wife on Monday night over some property dispute and later took her to Deen Dayal Upadhyaya hospital by 108 ambulance. According to the police, the authorities were informed of a dead body arriving in the hospital on Monday night and they suspected that the woman had died under suspicious circumstances. The police questioned the accused about the death of his wife but he did not reveal much during the preliminary inquiry. Subsequently, the police gathered information about the accused and his dead wife from the neighbours and then in-




terrogated the accused strictly again resulting in him reportedly confessing to killing his wife. According to him, he got married to his wife Usha three years ago in 2019 and they have been fighting on property issues for quite some time, as per the police. They had a fight on the same issues on Monday night too when the accused killed his wife by repeatedly hitting on her head with a bat when they were

about to go to sleep, stated the police. Subsequently, he hid the bat on the roof before calling the ambulance and took the body to the hospital, said the police. The police also informed that the first wife of the accused had died many years ago and his two sons also died in 2015 and 2016 due to health issues after which he married his second wife in 2019. The officials said that Dalanwala councillor Nikhil Kumar has given an application regarding the murder in the police station considering which, the police filed a case and arrested the accused on Tuesday.

BJP discusses strategy for 144 LS seats it lost in 2019

Feedback on probable candidates for 144 Lok Sabha seats which the BJP lost narrowly in the 2019 Lok Sabha polls and analysis of the pattern of voting along with suggestions for "better coirdination" at booth level committees in these constituencies ahead of the 2024 general elections were the issues discussed by BJP leaders here on Tuesday in a meeting attended by Union Home Minister Amit Shah and party president JP Nadda.

Over 25 Union Ministers, including Bhupender Yadav, Giriraj Singh, Smriti Irani, Parshottam Rupala and Gajendra Singh Shekhawat, were among those who were present in the key meeting at the BJP headquarters.

The big BJP huddle was one of the 'series' of "continuous discussions" undertaken by the party leadership to bring "clarity" on the strategy to win "350 Lok Sabha seats" in 2024, sources said. " In 2019, from 282 seats we increased to 314,"



they said. The seats lost in 2019 spread over several states including Uttar Pradesh, Maharashtra, Telangana, Punjab and West Bengal.

As part of the strategy, the party classified these 144 seats in groups with identical issues as also where BJP stood a close second or third in the poll outcome. One Union Minister each is made in-charge of each group tasked to give a "winning strategy" to the party leadership.

All 144 Lok Sabha constituencies have been visited, surveys carried out in assembly segments and a list of probable candidates in each

constituency is being prepared to whet it further with the micro level inputs by people outside the party structure, sources said.

The Ministers gave detailed presentations such as electoral profile, voting pattern in urban and rural segments, weak areas, latest feedback of local level surveys on the respective constituencies designated to them.

Caste profile of each of 144 constituencies was deliberated extensively and more visits by the central leaders to these constituencies have been planned to implement "corrective measures", they said

India-Oz ties moving into higher orbit: Jaishankar

Minister also hails Australia as an early and vigorous supporter of India's Indo-Pacific Oceans Initiative

With ties between the two countries on an upward trajectory, External Affairs Minister S Jaishankar on Tuesday hailed Australia as "an early and vigorous supporter" of India's Indo-Pacific Oceans Initiative (IPOI) and said the relations between the two countries have shifted gears and moved into a higher orbit.

Making this observation in an online address to the Australia-India Leadership Dialogue 2022, he also said a trade of over \$20 billion and investments at the \$25-billion level stand to rapidly expand by the Economic Cooperation and Trade Agreement concluded in April 2022.

Jaishankar said Australia is a major educational destination

for Indian students, who number in excess of 100,000, while the Indian community, estimated at 7.2 lakh, is a source of strength for both societies. "But it is really in the realm of politics and strategy that the transformation has been the sharpest. Much of the growing convergence has been driven by concerns about the region's stability, prosperity and security," Jaishankar said.

He further said the deficit in global goods has been sought to be addressed by India and Australia working together bilaterally as well as in larger formats.

"This reflects their shared concerns about respect for international law and a rules-based order. The two countries may have long interacted in ASEAN-led forums, Commonwealth, Indian Ocean Rim Association, etc.

But stronger leadership and more open exchanges have brought out mutual benefits of closer cooperation and coordination. "Australia has been an early and vigorous supporter of India's Indo-Pacific Oceans Initiative (IPOI). In fact, the big change has been realization that a stronger bilat-

eral relationship today allows the two nations to contribute much more effectively at a regional and at a global level," he added. The IPOI builds upon the 'Security and Growth for All in the Region'

(SAGAR) initiative announced by Prime Minister Modi in 2015. The Australia-India Indo-Pacific Oceans Initiative Partnership (AIIPOIP) in particular is focussed on maritime cooperation in the Indo-Pacific to support an open, inclusive, resilient, prosperous and rules-based maritime order.

Jaishankar also talked about a new intensity in the interactions between the two countries from the leadership level downwards and referred to a number of agreements in recent months.

These include pacts ranging from maritime collaboration, defence science exchanges, mutual logistics support to cooperation in cyber-enabled critical technology, critical and strategic minerals, water resources management, vocational education and training, as well as public administration and governance.

Sanjay Kumar Verma appointed High Commissioner to Canada

The Government on Tuesday appointed seasoned diplomat Sanjay Kumar Verma as India's next High Commissioner to Canada, while Amit Kumar, currently Consulate General of India in Chicago, will be the next ambassador to the Republic of Korea.

Verma, a 1988-batch Indian Foreign Service (IFS) officer and presently India's Ambassador to Japan, is expected to take up the assignment shortly, the Ministry of External Affairs said in a statement.

He succeeds Acting High Commissioner Anshuman Gaur. Amit Kumar, who joined the Indian Foreign Service in 1995, was earlier Deputy Chief of Mission in the Embassy of India, Washington DC with Ambassador-rank. PNS

BJP hits out at Nitish after his meeting with Rahul

Your bid to unite Opp won't bear fruit, there is no vacancy for PM's post, says Prasad

A day after Bihar Chief Minister's Nitish Kumar met former Congress president Rahul Gandhi in his bid to "unite" Opposition leaders in the run up to the 2024 Lok Sabha polls, the BJP on Tuesday claimed that his efforts would not bear any fruits as "there is no vacancy" for the Prime Minister's post and reminded him that many opposition leaders were "already in the queue."

"Nitishji! Rahul Gandhi ke saath aapki muskurati tasveer TV aur akhbaron mein dekhli. Socha, aapko smaran karau ki aap toh Dr Ram Manohar Lohia ke shishya hain jo gair Congresswad ke pahle pravartak thay. Aaj kahan chale gaye aap," tweeted Senior BJP leader and former union minister Ravi Shankar Prasad in Hindi.

The BJP leader sought to remind the Bihar Chief Minister that he is the disciple of Dr Ram Manohar Lohia who was the first promoter of

"anti-Congressism". Prasad suggested that Nitish was defeating the ideas espoused by Lohia by meeting the Congress leader. Prasad said that efforts of uniting opposition was made in the past met with no success and that there are several claimants to the Prime Minister's post in the opposition camp and he being only one of them in the queue.

"What you are doing today — knocking on every door — is not new. Many did the same before you but with no result. There is no vacancy for the prime minister's post. But many opposition leaders are already in the queue. You too stand," Prasad said.

"Had Nitish Kumar been proactive in developing Bihar like he is for his personal ambition, many Bihari youth would have got employment opportunity," the former Minister took a swipe in yet another of his tweet.

BJP's Rajya Sabha member and former deputy-chief Minister Sushil Kumar Modi also described Nitish's visit to the National Capital as "political tourism".

BJP and JDU are locked in a war words over several political issues following JDU's sudden exit from the BJP-led National Democratic alliance, last month, and Nitish forming a new coalition government with RJD, Congress and other parties in Bihar.

SC may refer Shinde faction plea to Constitution bench

The Supreme Court on Tuesday took note of the Eknath Shinde faction's claim about the Uddhav Thackeray camp stalling the proceedings before the Election Commission where the former's application staking claim over the Shiv Sena and its symbol is pending, and said it will consider listing its plea before a Constitution bench.

The Election Commission is seized of a plea by the faction led by Chief Minister Eknath Shinde seeking it be declared the real Shiv Sena and granted the party's bow and arrow poll symbol.

The top court, while referring to a five-judge constitution bench several questions related to defection, merger and disqualification arising out of the recent Maharashtra political crisis had on August 23 directed the Election Commission not to pass any order on the Shinde faction's plea.

"According to us, there was no interim order. The court had granted an extension of time to the other side (Uddhav group). Now, the other side is stalling the proceedings before the Election Commission.

Some elections are coming up in the month of October in the state," senior advocate N K Kaul, appearing for the Shinde faction, told a bench headed by Chief Justice UU Lalit.

"I will look into that and I cannot say anything off the cuff, but certainly, there will be something by tomorrow," the CJI said.

A bench headed by the then CJI N V Ramana (since retired) had on August 23 referred to a five-judge bench the petitions filed by both the factions of Shiv Sena.

UP Govt opposes Kerala journo's bail plea, alleges he has close links with PFI

The Uttar Pradesh Government has opposed the bail plea filed by Kerala journalist Siddique Kappan in the case filed against him under the Unlawful Activities Prevention Act (UAPA).

In an affidavit filed before the Supreme Court on Monday, the State Government said that Kappan has close links with extremist organisation Popular Front of India (PFI), which has an anti-national agenda and he was part of the larger conspiracy with the co-accused (including the financial launderer of CFI, Rauf Sharifi) to foment religious discord and spread terror in the country especially in the wake of anti CAA protests and violence, the Babri Masjid decision of this Hon'ble Court and the Hathras incident.

"The anti-national and terrorist PFI conspiracy and agenda dates back to 2010 (when PFI cadres (ex SIMI) had brutally maimed (hacked off the hands) of Christian Lecturer TJ Thomas of Newman College, and to 2013 when a PFI-backed weapons training terrorist camp was raided by the Kerala police at Narath, an investigation which was later taken over by the NIA," said the affidavit, opposing bail petition.

Kappan who worked in PFI's newspaper Thejas was arrested on October 5, 2020 on his way to Hathras along with other two PFI leaders. Kappan was Delhi Unit Secretary of Kerala Working Journalists Union. Kappan's claim was he as a journalist was going to report the rape and murder incident in Hathras.

Top court to hear from Sept 13 plea against Govt's call for 10% quota to EWS in jobs/admission

The Supreme Court on Tuesday said it would begin hearing from September 13 a batch of pleas on the cuffed, but certainly, there will be something by tomorrow," the CJI said.

The bench assured all the counsel that they would be provided adequate opportunity for advancing arguments and said it would assemble again on Thursday to pass directions to ensure smooth hearing on as many as 40 petitions. "Some suggested issues, framed by Gopal Sankarnarayanan, a senior advocate of this court, have been submitted.

These draft issues be circulated among all the counsel and after consulting all the crystallised version of all the issues be placed before this court on Thursday (September 8)," said the bench which also

comprised Justices Dinesh Maheshwari, S Ravindra Bhat, Bela M Trivedi and J B Pardiwala. Most of the petitions, including the lead one filed by 'janhit abhiyan' in 2019, challenge the validity of 103rd Constitutional Amendment Act, 2019, which provides for quota for EWS category candidates.

The Centre, through the 103rd Constitutional Amendment Act, 2019, introduced the provision for Economically Weaker Sections (EWS) reservation in admissions and public services.

Earlier, the Centre had told the apex court that its law, granting 10-per cent quota for Economically Weaker Sections (EWSs), was brought in to promote "social equality" by providing "equal opportunities in higher education and employment to those who have been excluded by virtue of their economic status".

The Government had said the new law will not be covered by the Indra Sawhney versus Union of India (popularly called Mandal Commission verdict) verdict of 1992 as provision for reservation was made after amending the Constitution.

India, Mongolia talk ways to boost defence, strategic cooperation

India and Mongolia on Tuesday discussed ways to further enhance bilateral defence and strategic ties during talks between Defence Minister Rajnath Singh and his counterpart Lt General Saikhanbayar Gursed in Ulaanbaatar. Rajnath is the first Defence Minister to visit Mongolia.

Giving details of his engagements, defence ministry officials said here Rajnath also called on the President of Mongolia Ukhnaagiin Khurelsukh and Chairman of State Great Khural.

The defence minister also inaugurated a Cyber Security Training Centre, built with assistance from India and laid the foundation stone of the India-Mongolia Friendship School, to be constructed with Indian assistance. On bilateral talks, the officials said the two ministers discussed effective and practical initiatives to further expand bilateral defence engagements.

The two leaders deliberated on regional and global issues of mutual interest. Both Ministers reaffirmed their commitment to fully implement the Strategic Partnership based on mutual trust and

understanding, common interests and shared values of democracy and rule of law. The two Ministers also reiterated their resolve to reinvigorate the India-Mongolia Joint Working Group (JWG), which will meet in India later this year.

In his interaction with the Mongolian president, the two leaders recalled their strong bonhomie and previous interaction in 2018 when together they laid the foundation stone for the ongoing oil refinery project being undertaken by assistance from India.

Rajnath also met Chairman of State Great Khural of Mongolia G Zandanshatar.

Rajnath along with Minister of Education and Science of Mongolia, laid the foundation stone of the India-Mongolia Friendship School, which is being established with the assistance from Government of India.

India established diplomatic relations with Mongolia in 1955. Mongolia has declared India as a strategic partner and "spiritual neighbour". In 2015, "strategic partnership" between the two Asian democracies was declared during the visit of Prime Minister Narendra Modi. Defence is an important element of bilateral engagements with Mongolia.

Hasina announces Mujib Scholarship for Indian martyrs of 1971 B'desh war

New Delhi: Prime Minister of Bangladesh Sheikh Hasina on Tuesday announced Mujib Scholarship for direct descendants of the Indian soldiers killed or grievously injured in the 1971 Bangladesh Liberation War.

The awards will be conferred on Wednesday, she said. The award is named after Bangabandhu Sheikh Mujibur Rahman, Hasina's father. A total of 200 family members of Indian Army personnel will receive the scholarship.

"We are grateful for valuable support from government and people of India in great war of liberation of Bangladesh in 1971, which was a watershed moment in our bilateral relations....Tomorrow, I will confer Mujib Scholarship to the direct descendants of soldiers

or officers of defence forces of India who were martyred or gravely wounded during Bangladesh Liberation War," Hasina said. As many as 1,984 Indian Army personnel were killed in the war, according to the Bangladeshi government.

The Hasina government had earlier honoured other Indian supporters of the freedom movement of Bangladesh, including writers and politicians. In the past, Hasina had also proposed to confer similar honours to those soldiers who laid down their lives to liberate the country. Hasina, who is on a four-day visit to India, also oversaw the signing of a memorandum of understanding (MoU) between Prasar Bharti and Bangladesh Television (BTV) on cooperation in broadcasting. PNS

Around 250 terrorists waiting across LoC

Army gears up to counter design

With intelligence reports suggesting presence of around 250 terrorists across launch pads in PoK, the army along the Line of Control (LoC) has upped its ante to counter any nefarious design from across the border.

Maintaining a high vigil at the forward post in Keran sector, the northern most part of Kashmir along LoC, troops are maintaining a birds-eye vigil despite ceasefire between two countries since February last year. For soldiers at this frontier, it's a battle that has to be fought

on two fronts — hostile neighbour and harsh winter, which is approaching. Though the claims of army that infiltration has reduced in the past few years, officials, who spoke to a group of visiting journalists, said there were intelligence inputs about presence of about 250 terrorists at various launch pads waiting across the LoC to sneak in. "So, we cannot let our guard down," one of army officials said.

Besides infiltration of terrorists, the army is also worried about flow of drugs from across border. Recently, Director General of Jammu and Kashmir Police Dilbag Singh said smuggling of drugs from across border is on rise and Pakistan is using it to fund terrorism in Kashmir.

NMC allows Ukraine medicos to move to colleges in other countries

The National Medical Commission (NMC) has allowed the medical students who had to return to India due to the Russia-Ukraine war to transfer to colleges in other countries. Earlier, students studying medicine in a foreign country were not allowed to shift their country of study mid-course.

Considering the special circumstances, the NMC in its recent notice said, "NMC conveys its no-objection for acad-

emic mobility program in respect of Indian medical students who are studying in Ukraine provided that other criteria of Screening Test Regulations 2002 are fulfilled.

The earlier rule stated, "the entire course, training, and internship or clerkship shall be done in the same foreign medical institution throughout the course of study and no part of training/internship shall be done from another institute." "It is informed that the mobility program offered by Ukraine has been considered in the Commission in

consultation with the Ministry of External Affairs, wherein it was intimated that the academic mobility program is a temporary relocation to other universities in different countries globally.

However, the degree will be awarded by the parent Ukrainian University," NMC said in its latest order. Even though universities in Ukraine have started to operate, students are not going to the varities due to geopolitical conditions. Most of the students are attending classes online, however, NMC only recog-

nizes theory classes online and a considerable portion of medical education is practical education. Thus, Ukraine-returned students are looking for alternative solutions. A majority of Ukraine-returned students demanded to be given seats in Indian private medical schools as a temporary solution.

The Supreme Court had earlier this year had asked NMC to chalk out some measures to help these students to complete their courses and training. But NMC stated that accommodating them in Indian colleges was not possible.

Taken up as challenge to restore rain-ruined Bengaluru, says CM

Karnataka Chief Minister Basavaraj Bommai on Tuesday blamed the previous Congress Governments’ “mal-administration” and unprecedented rains in the capital city for the deluge.

He said, despite all odds, his Government has taken it up as a challenge to restore the rain battered city, and make sure that such things don’t recur in the future.

Owing to the torrential downpour that lashed the state capital for the last couple of days, several areas are still under water with houses and vehicles partially inundated, there by affecting normal life.

“Karnataka, especially Bengaluru has not received unprecedented heavy rain. For the last 90 years such rain has not been recorded. All the tanks are full and are overflowing, some of them have breached, and there have been

continuous rains, every day it is raining,” Bommai said.

Speaking to reporters here, he said a picture is being portrayed that the entire city is facing difficulties, which is not the case.

“Basically the issue lies in two zones, particularly the Mahadevapura zone for reasons such as presence of 69 tanks in that small area and almost all of them have either breached or are overflowing, secondly, all establishments are in low lying areas, and the third is encroachments,” he listed out.

Noting that his government has taken it as a “challenge”, the CM said officers, engineers and workers and State Disaster Response Force (SDRF) teams are working 24/7.

“We have cleared lots of encroachments and we will continue to clear them. We are installing sluice gates to the tanks so that they can be man-

Several streets, areas still inundated in State

The situation in several parts of rain battered Bengaluru, by and large continued to remain the same on Tuesday, with streets waterlogged, houses and vehicles partially inundated, as torrential downpour lashed the capital city on September 5 night.

Using boats and tractors to cross the streets submerged in water by office goers and school children was a common sight this morning in several parts of the city like Yemalur, Rainbow Drive layout, Sunny Brooks Layout, Marathahalli among several others. “I came by tractor as roads are all submerged in water, also our vehicles are under water... I have exams from tomorrow, so I have to go to school,” a girl

dressed in school uniform said.

“Water has not receded, as there was rain once again last night (Monday), in fact I feel it has increased. I have to go to the office, kids have schools, and I somehow used a tractor today. Request the government and authorities to do something and restore normalcy,” said an office goer.

According to Chief Minister Basavaraj Bommai, some areas in the state capital have received 150 per cent more rains than normal between September 1 and 5. Mahadevapura, Bommanahalli and K.R.Puram have recorded 307 per cent excess rain. “This was the highest rainfall in the last 42 years. All the 164 tanks in Bengaluru are filled to the brim,” he said.

and unplanned administration” of the previous Congress governments for the present misery, Bommai said they had given permissions for construction activities “right-left-centre” in the lake areas, on the tank bunds and buffer zones.

They had never thought of maintaining the lakes, he said.

23-yr-old woman electrocuted

A 23-year old woman, who allegedly died due to electrocution after she came into contact with an electric pole while navigating a road flooded with rain water here was a “pillar of support” for the family, both financially and morally.

With aged parents and a handicapped brother at home, Akhila started working after completing her graduation to support the family’s needs.

Akhila worked in the administration department of a private school. “We (parents) had called her last night and she had told me that she will come home, once the rain stops...No child should face what my child faced. Our life was dependent on her earnings, my wife can’t work, son is handicapped...,” Akhila’s father Somashekar said.

“Now I have taken it up as a challenge. I have given Rs 1,500 crores for development of storm water drains, I have yesterday released Rs 300 crore to remove all encroachments and do a pucca structure along the storm water drains and for the infrastructure, so that there are no impediments and bottleneck in the flow of water.”

Cong to launch ‘Bharat Jodo Yatra’ in Kanyakumari

The Congress is all set to launch its 3,570-km ‘Bharat Jodo Yatra’ on Wednesday at a mega rally in Kanyakumari with former Congress president Rahul Gandhi to take part in a prayer meeting at former Prime Minister Rajiv Gandhi’s memorial in Sriperumbudur.

It will be followed by an event where DMK leader and Tamil Nadu Chief Minister M K Stalin, Rajasthan Chief Minister Ashok Gehlot and Chhattisgarh CM Bhupesh Baghel will be present where Rahul will be handed over a Khadi national flag.

Stalin is in a coalition Government with Congress and the grand old party has invited all the like minded parties to join the Yatra which seeks to highlight the plights of economic disparities, social polarisation and political centralization amidst host of issues concerning the general citizens.

Before the launch of the yatra, Rahul will also visit the Vivekananda Rock Memorial, Thiruvalluvar Statue and Kamaraj Memorial in Kanyakumari. Though the 3,570-km yatra from Kanyakumari to Srinagar, covering 12 states and two Union Territories in about five months, will be formally launched at the rally, it will actually begin at 7 AM on September 8 when Rahul and



several other Congress leaders will embark on the march.

Ahead of the Yatra, Rahul has said that with all paths allegedly blocked by the government, the Congress now has to go to the people and tell them the truth, and that is why the party is undertaking the ‘Bharat Jodo Yatra’.

The ‘padayatra’ will move in two batches, one from 7-10:30 am and the other from 3:30 pm to 6:30 pm. While the morning session will include a lesser number of participants, the evening session will see mass mobilisation. On an average, the ‘padayatri’s plan to walk around 22-23 km daily. Congress has asserted that its Yatra from Kashmir to Kanyakumari is not a ‘Mann Ki Baat’ in any manner, but its objective is to ensure that the concerns and demands of the people reach Delhi.

The party has classified 119 leaders, including Rahul Gandhi, as ‘Bharat Yatri’s’ who will walk through the entire distance from Kanyakumari to Srinagar. The ‘padayatra’ will reach Kerala on September 11 and will traverse through the State for the next 18 days.

Centre likely to sign peace accord with Assam Adivasi ultras: CM Biswa

Assam Chief Minister Himanta Biswa on Tuesday said the Centre is likely to sign a peace accord with militant organisations from the State’s Adivasi communities within September.

Addressing a Press conference after a Cabinet meeting here, he said his Government has found a gap of around 50 lakh beneficiaries after linking Aadhaar cards with ration cards across the State.

“The Central Government is likely to sign a peace accord with militant groups from the Adivasi communities of Assam within this month,” Sarma said.

Without sharing any detail, he said that the entire process is being carried out under the initiative of Union Home Minister Amit Shah.

A senior official from the Assam Police headquarters told PTI that five militant groups are likely to sign the peace agreement. These groups are All Adivasi National Liberation Army, Adivasi Cobra Militant of Assam, Birs Commando Force, Santhal Tiger Force and Adivasi People’s Army.

“These groups have been in ceasefire for many years after announcing Suspension of Operations. Their cadres live at designated camps under police protection,” the official said.

The central government in January 2020 signed an agreement - Bodo Peace Accord - with militant group National Democratic Front of Bodoland (NDFB).

BSF silences Pak Rangers’ guns in Arnia; 2 Hizbul terrorists killed

Peace prevailing along the International border with Pakistan, since February last year, was once again shattered by the Pakistani Rangers by resorting to ‘unprovoked’ firing on the BSF patrol party near Chinaz border outpost in the Arnia sector of Jammu frontier on Tuesday.

In response the alert BSF troops gave a befitting response to silence their guns.

This is the first incident of ‘unprovoked’ firing targeting the Indian border guards this year. A similar incident was earlier reported in May 2021 in the Rangarh sub sector of Samba after both India and Pakistan had renewed their mutually brokered ceasefire agreement from the midnight of February 24-25, 2021. In



between a cross border tunnel was detected along the International border in the Samba sector besides several incidents of cross border narcotics smuggling, drone droppings and intruders trying to sneak in were reported in the region. Luckily, the BSF patrol party escaped unhurt. Official sources in the BSF confirmed, “no loss of life/injury was reported on ground zero”. Ground reports suggested, BSF personnel were engaged in the repair work of lights when Pakistani rangers targeted them around 9.00 am in the Arnia sector.

Meanwhile, two terrorists belonging to the pro-Pakistan Hizbul Mujahideen terrorist outfit were neutralised by the joint teak of the security forces at Poshkreeri area of Anantnag.

Both the killed terrorists have been identified as as Danish Bhat @ Kokab Duree & Basharat Nabi. They were affiliated with proscribed terror outfit Hizbul Mujahidden In a written statement Jammu and Kashmir police spokesman said, both the terrorists were involved in the killing of one Territorial Army personnel Saleem on 9 April 2021 & killing of two civilians on 29 May 2021 in Jابلپورا.

In Jammu, the BSF and Pakistan Rangers held a flag meeting hours after exchanging several rounds of fire and decided to adhere to the ceasefire agreement.

Madrasa survey in UP mini-NRC, move to harass Muslims: Owaisi

The Yogi Adityanath Government’s decision to launch a survey to identify the unrecognised madrasas and gather details such as organisations running them, curriculum and source of income has sparked a political row. The Opposition alleged that the exercise was meant to harass Muslims in Uttar Pradesh.

Jamiat Ulema-e-Hind, an organisation of Islamic clerics, said on Tuesday that they would not oppose the survey if it was done under the law. The Jamiat has also formed a steering committee to decide on the survey and asked madrasas in UP to maintain their accounts.

However, Jamiat president Maulana Mahmood Madani said, “The UP Government should try to understand, and



not misunderstand us.”

All-India Majlis-e-Ittehadul Muslimeen (AIMM) chief Asaduddin Owaisi said the exercise was not a survey but a “mini-NRC”.

He hit out at the UP Government for “harassing Muslims” and said the government could not interfere with their rights under Article 30 of the Constitution.

There are 16,513 recognised madrasas with about 20 lakh students in the state, according to the Uttar Pradesh Madrasa Shiksha Board.

Physically-challenged youth beaten to death by UP cops

A physically-challenged youth was allegedly beaten to death by police in Kaushambi district. As per reports, on receiving information about a minor dispute and clash between two parties on Monday, the police reached the spot and tried to forcibly take the youth to the police station.

When he resisted, a constable thrashed him with a rifle hook. The police left the scene after some neighbours intervened. The youth was rushed to a hospital where he was pronounced dead upon arrival.

The bereaved relatives alleged that the cops of Paschimshira police station killed him. The police sent the body for autopsy and also started a probe.

The superintendent of



police reached the spot and took stock of the situation. He assured action against the cops found guilty in the probe.

Meanwhile, allegedly tortured by loan sharks, the principal of a primary school committed suicide at his office in Karmaha, Maharajganj district, police said on Tuesday.

In a suicide note, the principal held three people responsible for him taking the extreme step. On a complaint by his wife, the police registered a case against the accused.

SC voices concern over people getting booked under scrapped Sec 66A of IT Act

Calling a “matter of serious concern” the registration of FIRs under Section 66A of the Information Technology Act it had scrapped in 2015, the Supreme Court on Tuesday asked the Chief Secretaries of States concerned to take back the cases within three weeks.

Under the scrapped section 66A of the IT Act, a person posting offensive content could be imprisoned for up to three years and also fined. Terming liberty of thought and expression “cardinal”, the top court had on March 24, 2015 done away with the provision, saying “the public’s right to know is directly affected by Section 66A of the Information

Technology Act”.

Later, it took a serious note of the use of the scrapped provision by the law enforcement agencies and issued notices to states and high court registries.

“It is the matter of serious concern that despite an authoritative pronouncement of this court by which the validity of the provision was set aside, the cases are still being registered,” a bench comprising Chief Justice Uday Umesh Lalit and Justice S Ravindra Bhat said on Tuesday.

The top court directed the chief secretaries of the states concerned to take remedial measures as early as possible and complete the exercise of taking back the cases in three weeks.

TMC leader raped, extorted cash for group D job: Victim

Even as the Trinamool Congress grappled with school level recruitment scams and other instances of corruption that have seen a number of senior party leaders, including Ministers going to jail, a new case of sex-for-job has burst in Bengal ruling party’s face.

A TMC block president has been accused of repeatedly raping a Group D job seeker besides extracting Rs 10 lakh from the victim.

The incident has taken place at Mangalkot region of Burdwan district, sources said.

Not only the TMC leader extracted cash for job from the woman and raped her but also

beat her up when she went to demand the money after the leader failed to provide her the job.

“I approached Pal da (the TMC leader) for Group D government job ... He asked for Rs 10 lakhs... Later even after repeated reminders he failed to arrange for the job ... He also raped me... And I conceived ... Subsequently when I asked him to return my money he beat me so severely that I suffered abortion,” the victim said.

The Burdwan Police refused to comment but a senior official said actions would be taken if the allegations were true.

Meanwhile, the Calcutta

High Court on Tuesday passes yet another judgement directing the State Government to immediately provide appointment to 54 candidates who could not get appointment due to lapses on the part of primary teachers appointment board.

The same court had earlier ordered CBI investigation into school level recruitment scam that ultimately saw former Education Minister Partha Chatterjee land in jail.

The Court had on Monday directed the Government to appoint 23 TET candidates in coming 23 days.

The Tuesday’s order provides respite to 77 candidates in two consecutive days.

Yogi Govt OK’s ₹193 cr aid for farmers in UP

In an attempt to provide the much-needed relief to farmers facing challenges, the Uttar Pradesh Cabinet, under the chairmanship of Chief Minister Yogi Adityanath, approved an aid of Rs 192.57 crore for them on Tuesday.

The amount will be used for weed control as well as safe storage of standing and ready crops in the field, using various ecological resources in the next five years.

In this regard, the required chemical and biological pesticides will be given to the farmers on a grant from

the Agricultural Defense Unit. A proposal to give a 50 per cent subsidy on storage units has also been approved for the safe storage of crops.

It is worth noting that farmers suffer huge crop losses due to weeds, insects, pests, damage due to unsafe storage, and rats every year.

To reduce the loss of farmers, the cabinet approved an assistance of Rs 192,57,75,000 for a period of five years from 2022-23 to 2026-27.

The government will spend Rs 34.17 crore in the current financial year for the benefit of farmers.

Four newly-wedded girls commit suicide in 3 days over dowry demand in Kerala

Five newly wedded girls dying due to murders and suicides in the last three days has shocked the Kerala psyche again.

Out of the five victims, four lost their lives as the fallout of ill treatment by the in-laws who demanded from the new brides more money and gold as dowry. Paravoor in Ernakulam woke up to a sad Monday morning as 22-year-old Amala was found hanging in her husband’s house.

The girl was found to be three months pregnant and was not allowed to speak with her parents in



Thiruvananthapuram. “It was an arranged marriage and the couple visited our house only twice after the marriage. My daughter is not one who resorts to suicide or extreme measures. There is foul play behind this death,” her mother told journalists on Monday. Police have registered a case over unnatural death and a probe is on to ascertain the factors that led Amala to resort to the extreme step.

Good for India

We can expect Truss' premiership to benefit us, given her tough stance vis-à-vis China

The mainstream media loves to lambaste and lampoon Rightwing leaders. Their shortcomings are magnified a million times and achievements shrunk in similar proportions. US president Ronald Reagan was ridiculed as a trigger-happy cowboy who mistook world politics for the Wild West; George Bush Jr was the butt of jokes among journalists; and Donald Trump was not just continuously mocked but also viciously maligned. In our own country, BJP leaders are often denounced not for what they say or do but for being what they are, for their political beliefs. So it should not come as a surprise that even before she took oath as British Prime Minister, Mary Elizabeth Truss began attracting uncharitable comments from political analysts. Perhaps this has something to do with her identification with Margaret Thatcher, the legendary British PM who, along with Reagan, brought down the Soviet Union. Thatcher, by the way, was another hated figure among the liberal establishment which is increas-



ingly being infected with all manner of Leftist viruses. Truss has already been called a political chameleon; she has been depicted as a leader whose stand on any issue is a function of expedience, not of principle. Once she was a Republican, favouring the abolition of monarchy, but now she, as a Conservative leader, seems to have discarded her antipathy towards monarchy. She opposed Brexit, but eventually went for it. All politicians, even great statesmen, change their views and give considerable concession to pragmatist policies, but Rightwing politicians are slammed more than others. Truss is no exception.

Third woman Prime Minister after Thatcher and Theresa May, Truss has promised to cut taxes and deal with a growing energy crisis. A massive economic crisis greets Truss, with inflation at 13 per cent, the highest in four decades, and projected by Goldman Sachs to climb to 22 per cent. Deutsche Bank has warned of the risk of a balance of payment crisis. The fiscal situation is also tight. Against this backdrop, Truss' insistence on no new taxes and less regulation will help, because it will help the economy. From India's perspective, her term should be good. She is likely to soon sign the comprehensive free trade agreement (FTA) with India. India is convinced of that. Commerce Secretary BVR Subrahmanyam said the "Diwali deadline is not going to be missed. Mark my words." Also, Truss is quite tough on China. In a speech earlier this year, she said, "China and Russia have spotted an ideological vacuum and they're rushing to fill it. They are emboldened in a way we haven't seen since the Cold War. As freedom-loving democracies, we must rise up to face these threats. As well as Nato, we are working with partners like Australia, India, Japan, Indonesia and Israel to build a global network of liberty." Such an attitude will help India counter a bellicose China better. In a nutshell, we can expect that Truss' premiership will benefit us.

Skipper fights back

Going by his track record as cricket captain, the fighter that Imran Khan is not going to be cowed easily

The way ousted Pakistan Prime Minister Imran Khan is taking on the new Government and Pakistan Army, it is clear that he is in no mood to be subdued and is not bowing out of Pakistan's unstable politics. He has become more aggressive after the Government slapped him with terrorism charges after he allegedly threatened the Islamabad police chief and a judge in his speech. He is accusing officials of delaying snap elections so that the successor of Pakistan Army Chief Gen Qamar Javed Bajwa can be chosen as per their desires. But since the present political dispensation and Army chief Gen Bajwa have made a common cause against him, it is very unlikely that his appeal for early elections would be heard. Bajwa is to retire in November. It is no secret that any civil Government in Pakistan needs to have the Army on its side and if that doesn't happen, the days of democratically elected Government are numbered.



Initially, Imran Khan was a blue-eyed boy of Army Generals and enjoyed a good rapport with Bajwa but they fell apart on the choice of the successor of Bajwa. He wanted to replace Lt Gen Faiz Hameed, the director-general of the Inter-Services Intelligence, Imran's favourite. Eventually, Bajwa removed Hameed and soon the two parted ways. It is not that Imran doesn't have support in the Army. He does and that is where his confidence comes from but his open criticism of the Pakistan Army is doing him no good as he has questioned the credentials of top Generals. This means he would be

having more enemies than friends in the Pakistan Army even after Bajwa's departure. The Generals are not going to like the insults heaped upon them; after all, the military has ruled Pakistan directly or by proxy since its birth. Imran Khan was removed from his post on April 10 this year. He maintains it was on the US behest, though his fallout with Bajwa is closer to the truth. But since then he has maintained pressure on Shehbaz Sharif's Government. But by roping in the Army into his tirade, Khan is walking a tightrope. He even went on to say that Sharif's Government wanted to avoid the 'patriotic' Army chief, the ultimate insult to any Army personnel. He is also doing some serious disservice to 'jhamooriya' in his country by openly politicising the Army and involving them in the political process. But then that is how Pakistani politics has always been!

After much ado, Truss is UK PM

Liz Truss beats Rishi Sunak by a whisker but the ex-Finance Minister did create history of sorts by coming so close to 10 Downing Street

I'm wandering across Scotland spreading time between tasting Scotch, admiring the stunning terrain, imbibing the Scottish way, and witnessing historic political events in the UK from Melrose, on the Scottish-English border. Dominating the news are two events: the battle for No 10; and the embarrassing failure of *HMS Prince of Wales* to sail.

At 12.30 PM Monday, the Conservative Party at Westminster chose Foreign Minister Liz Truss over Rishi Sunak with a surprisingly small majority to become Prime Minister of Britain following the coup against Boris Johnson in July. Truss's win was widely predicted and only a miracle could have helped Sunak win. Commentators said they would 'eat their hat' or any other item of accouterment was Truss to lose. The UK is not yet ready to have a non-White as Prime Minister.

At 96, the ailing but most loved Queen did not ask the heir to the throne, Prince Charles to swear in Liz Truss, a ceremony that was performed for the first time at Balmoral Castle during her 70-year reign and not Buckingham Palace where thousands of tourists pay Pound Sterling 30 (Rs 3000) for a guided tour. Instead, yesterday the Queen received the PM-in-waiting Truss for the 'kissing of the hand', forming the government, and a photograph. In 1908, King Edward VII gave an audience to Herbert Asquith when the monarch was relaxing at the French coastal resort of Biarritz. Both Truss and Sunak had agreed to meet the Queen wherever she was, with Sunak adding: "the PM serves her Majesty". For Indians, Sunak reaching so close (and yet so far) to becoming PM must be something to celebrate.

On 27th August, the Daily Telegraph put out a two-page supplement for its guestimate of the Truss cabinet. Expected for the three most senior posts of Chancellor, Home Secretary, and Foreign Secretary are Kwasi Kwarteng, Suella Braverman, and James Cleverly. Kwarteng is a free marketeer and a consistent political ally of Truss. Together they have advocated low taxes, low



regulation economy, and minimum governance. John Redwood and Jacob Rees-Mogg are likely to assist the Chancellor. Braverman will have the challenging mission of ending illegal immigrants across the Channel (last Sunday 1061 crossed over). She's known to have favoured their deportation to Rwanda, since suspended by the courts. Braverman, a child of Kenyan and Mauritian immigrants had described the British empire as "on the whole, a force of good". For Foreign Secretary, Truss' likely choice and replacement are James Cleverly assisted by Tom Tugendhat, who was one of the PM aspirants. Cleverly was a junior minister in the Foreign Office. Tugendhat, a former Army officer, and like Truss a China hawk is chairman Foreign Affairs select committee. Ben Wallace, the current Defence Minister, is likely to keep his job. He has advocated a higher defence budget which agrees with Truss's pledge to raise it to 3 per cent of GDP. Some other 'likelies' in the Cabinet are Sir Ian Duncan Smith as leader of the House, Nadeem Zahawi whose lead-

ership bid failed spectacularly, as Health Secretary, and Ranil Jayawardene of Sri Lankan descent as Environment Secretary. Whether Sunak will be in is the big question. He has said he wants to support the Conservative Government in "whatever capacity".

Sajid Javed who triggered the coup against Boris Johnson and later backed Truss may be rewarded with a ministerial post. Big names likely to be left out are Rishi Sunak, Dominic Raab, and Alok Sharma. The Truss government faces enormous economic challenges especially meteoric energy bills. While the pound sterling is struggling, funding the National Health Service is the other big challenge. The never-ending row with France is back in the spotlight. When asked last week whether she considered Macron a friend or foe, Truss replied: 'the jury is out'. Macron's response: 'The UK is a friendly nation, regardless of its leaders'. Macron added: 'if Britain and France cannot determine whether they are friends or enemies, then we are heading for serious problems. An embarrassing event

that Britain could have done without last week was the failed maiden voyage to the US of the UK's largest (65,000 tonnes) aircraft carrier, HMS Prince of Wales, dedicated to Nato. Earlier this year, the second aircraft carrier, Queen Elizabeth, was on a long tour of the Indo-Pacific which included exercises with the Indian Navy. A British Gurkha veteran I spoke to, was puzzled about the four-year Agnipath scheme. Operation Bojo (return of Boris Johnson as PM) many Brits feel, could happen before Christmas following a no-confidence vote in Truss so that he can lead Tories into elections in January 2025. Labour is ahead in the recent polls. India is hoping the FTA under India-UK Comprehensive Strategic Partnership due by Diwali will happen and the price of Scotch will be deregulated. Cheers from Melrose!

RIISING FATALITIES ON THE ROAD

Sir — The fatal road accident involving former Tata Sons chairman Cyrus Mistry once again brings into focus the high number of deaths caused in such incidents every year in the country, with Government data showing that a record 1.55 lakh lives were lost in 2021. Mistry, 54, was killed after his car hit a divider in Maharashtra's Palghar district while travelling from Ahmedabad to Mumbai in a Mercedes car. According to the recent National Crime Records Bureau data, over 1.55 lakh people were killed in road crashes across India in 2021 — an average of 426 daily or 18 every single hour.

This is the highest death figures recorded in such accidents in any calendar year so far. Besides the deaths, 3.71 lakh people were also injured in 4.03 lakh road accidents across the country last year, shows the NCRB figures under the 'Accidental Deaths & Suicides in India 2021' head. The data showed a majority (59.7 per cent) of the road accidents were due to speeding, accounting for 87,050 deaths and injuries to 2.28 lakh persons. With Mistry's death, the focus has already come back to the alarming increase in road accidents.

Political scene is hotting up



In an intriguing turn of events at the national political stage, Bihar Chief Minister and veteran political leader Nitish Kumar has surpassed a couple of his counterparts including West Bengal's Mamata Banerjee, Tamil Nadu's MK Stalin and Telangana's K Chandrashekar Rao in the race to the united Opposition's prime ministerial candidate in the general elections due in 2024, thanks to Nitish's success in clutching to power as the Chief Minister for a record fourth

time with the support of the RJD and other non-BJP outfits following his differences with the Speaker that snowballed into a major controversy leading to the political flip-flop.

Emboldened by his signature masterstroke, Nitish is on a three-day visit to the national Capital, obviously with a view to mustering support in this regard. Ironically, five of the six JD(U) legislators in Manipur have switched over to the BJP in the meantime. Already beleaguered by its internecine bickering, the 'grand old party' has maintained a studied silence vis-a-vis the groupings of the Opposition parties against the formidable BJP taking place in the run-up to the Lok Sabha polls. The warship's keel laying was done in 2009. The 262-metre-long and 62-metre-wide 45,000-tonne carrier can carry 10 helicopters and 20 warplanes on board. Cochin

Shipyard at Kochi is the largest shipbuilding facility in the country. It started its operations in 1982.

SAIL, HAL, Tata, L&T, Wartsila, Kirtloskar Pneumatics and public sector undertakings, Bharat Electronics Limited and Mishra Dhatu Nigam, that played a pivotal role in putting together the warship's structure and contributed prominently to the carrier's construction, came into being many years ago. THERE IS NO WILL TO LIMIT NOISE POLLUTION

The SC should fix accountability for noise pollution in States

News report last year about ill effects of noise pollution said that a poultry farmer in Odisha's Balasore district reported more than 60 broiler chickens in his farm dying due to heart attacks. That was caused by loud music coming from a bridegroom party that came to his village. According to the report, Ranjit Parida, the farmer, said that the bridegroom's wedding procession came to his village around 11 pm on the day of the incident and started playing loud music and also burst loud firecrackers.

The farmer requested people in the marriage procession to lower the volume but they were all drunk. Terrified chickens in his farm started running around in fear and an hour later Parida found 63 chickens dead, according to the news report.

When the aggrieved farmer consulted with a local veterinarian, he said that the loud noise had caused the birds to go into shock, killing them. It is reported that an FIR has been lodged with the local police.

We can't ignore this as a stray incident, as all over the country, throughout the year, some noise pollution is allowed to exist and no one seems to bother the ill-effect on the health of human beings and other living creatures. Temple functions, marriage parties, political meetings, etc., are invariably organized with loud music through cone loudspeakers.



In July 2005, the Supreme Court banned the use of cone speakers after it was found that they produce very high decibels of sound compared to the box-shaped sound systems. But in any city one can see that many residents complain that the Pollution Control Board does not take any action against such users of cone speakers.

Now there is a fresh debate on the use of loudspeakers by places of worship in the country. In April this year, the Uttar Pradesh Home Department said that illegal loudspeakers will be removed from religious places across the state. It also said that loudspeakers flouting the noise limit standards will be removed. This was following the statement of the Chief Minister that loudspeakers can be used at religious places with permission but the sound must not come out of the premises. He also said that no new permits will be issued for loudspeakers.

In August 2016, the Bombay High Court ruled that the use of loudspeakers was not a fundamental right. The Bombay High Court observed that no religion or sect could claim that the right to use a loudspeaker or a public address system was a fundamental right conferred by Article 25 of the Constitution of India.

On June 26, 2018, the Uttarakhand High Court set a five-decibel limit for loudspeakers, but modified in July 2020 the order, limiting the noise level at five decibels calling it an "accidental error".

In September 2018, the Karnataka High Court banned the use of loudspeakers after 10 pm. In July 2019, the Punjab and Haryana High Court banned the use of loudspeakers at public places, including religious bodies.

On May 15, 2020, the Allahabad High Court held that azaan could be recited by a muezzin from minarets of the mosques by human voice only without using any amplifying device or loudspeakers. On January 11, 2021, the Karnataka High Court directed the state government to act against illegal loudspeakers at religious places in the state.

The real issue is not absence of legal provision but absence of execution of the directions of various courts, including that of the Supreme Court.

A Barefoot journey to lifelong live learning

Accessible quality education rooted in indigenous wisdom is the mantra at Tilonia's Barefoot College

Rajasthan: An engineering class is underway. The 45 students are grandmothers from 10 different countries. None of them have formally studied science. In fact, most of them are semi-literate. Dressed in a ghaghra odhni, their rural instructor Magan Kanwar doesn't speak any of their languages or even English. But their communication is perfect, as she instructs them on assembling circuits for solar lamps. This group of women, after a six-month training, will return to their respective villages and electrify them. If you thought this was unusual, this is just one of the multiple uncommon but highly effective educational innovations at Social Work and Research Centre, Tilonia's Barefoot College, located in the heart of rural Rajasthan, 110 kilometres from Jaipur.

In the past half-century, it has stood for bringing together technology, communication, education and handicrafts for the betterment of the rural communities rooted in traditional wisdom and practiced through Gandhian values. The college, right from the beginning, has been putting into practice all the values of modern education: breaking silos between subjects, experimental and hands-on learning and most important of all learning for change and impact.

In 1975, the institution began with evening literacy classes for 15-35-year-olds. As the student body expanded across villages, so did the numbers of Night Schools. Community-run village education committees (VEC) appointed local teachers provided with uniform training on basic subjects, civil and Constitutional rights.

Learning in these schools is integrated in the pupils' lives. They learn mathematics through the number of animals they take for grazing and science through the concepts they see around them. Local and relevant environment issues are added to the teaching alongside agriculture and animal husbandry, because most of them tend cattle. Though the journey is barefoot, the approach is modern and updated, and 2014 onwards, when it was seen that digital growth is imperative to education, Barefoot College equipped the schools with technology and thus began Solar Digital Night Schools. These Night Schools across 10 states have impacted 80000+ working children.

As far back as 1988, Shiksha Niketan, a primary school for low-income, marginalised children, practised methods we often associate with modern pedagogy: experiential learning, learning from one's immediate environment, project-based learning and STEAM. "The mother of a child does at least 20 experiments in science every day. She does it without realising this is the study of science. The same concept is there in the book, but is unfamiliar territory for the child. We connect the students to the subject through examples of routine activities around them. The focus is on

developing the curiosity of the child," shares Durga Singh, a founder teacher of Shiksha Niketan.

The communication team simplifies a concept through puppets and the carpentry department becomes a lesson in geometry. Functional props, origami and visitors at Tilonia expand the perspective of the learners. "The alumni of Shiksha Niketan are in various government and other high-paying jobs across different levels. But there is a greater sense of pride when our alumni are recognised as good citizens of their villages, helping others grow along with themselves," says Singh.

Even Shiksha Niketan cannot meet the needs of 10-year-old Anshu, who moves with his nomadic sheep herder parents. Like him, there is an entire section of children of nomadic communities that cannot pursue education as their families constantly move for work. A six-month programme to address this gap was started in 2007 in the form of a residential Bridge School at Singla, 25 kilometres from Tilonia. The programme, now is 10-month-long, covers the entire syllabus till Class V for children between 8 and 12 years, who never went to school. Students from five districts come to this school where a greater preference is given to the enrollment of girls. Besides attending regular classes and extra work in the evenings, the students learn grooming and care. They play games and work with the volunteers to explore concepts in their academics through the simple, practical model that Tilonia creates. At the end of the course, the students take

the Class V exam via Shiksha Niketan and can then pursue their further education.

There is no rulebook in the ever-evolving lab of Barefoot experiments. However, the Barefoot College lives by the Constitution of India. From slates to iPads, this educational journey has kept up with contexts. So, with the implementation of the Panchayati Raj Act, a new model was created to explain the basic Constitutional framework to the children. In classic Barefoot style, it was learnt by doing.

A ward was made of 10-12 students and they elected one member representative. The ward representatives together formed a Bal Sansad. This Parliament chose its Prime Minister through an election that had proper canvassing and election symbols. Secret ballots were maintained. The PM chose a Cabinet and assigned roles. They participated in the various meetings of the organisation and gave recommendations to the programme coordinators. The children who grew up with this learning went on to mobilise people to get water supply lines to their village, agitated for removal of alcohol 'thekas' and even contested polls. Devika, as the PM of her Sansad, also went to Sweden to receive an award where she met the Queen and they exchanged notes as heads of institutions!

From making the campus self-sufficient in energy requirements back in 1996 to the renowned Solar Mamas programme that teaches components, colour coding and circuits of solar home-lighting systems to women from non-electrified villages, this transfer of solar energy to

the rural community has a three-layered impact. It sustains the villagers' need for electricity at reasonable costs through the most vulnerable section, the women. It lights up perspectives – a significant takeaway of education across all areas. Thirdly, it saves millions of litres of kerosene from being used as an energy alternative.

At the Barefoot College, string puppets evolved into more practical glove and rod puppets besides life-sized and giant puppets. Made of scrap cloth and paper, the puppets are contemporary characters identifiable by the villagers.


When they give out information about a programme or a government scheme, they both engage and simplify the concepts, creating wide-spread awareness. Traditional folk instruments and songs are part of the performance. This delightful, digital fatigue-free audio-visual medium has been working with the villages for the past 40 years.

The puppets go by relatable names to be one with the villagers. As Chetan Kaki and Dhanno Bua, they propagate equality and fight for women's rights. The revered puppet, Jokhim Chacha, the bard of Tilonia, is 365 years old.


"We engage the students in a conversation about various facets of learning. The puppet makes them curious through a peculiar style of talking based on the character," shares Ramnivas from the communications team. In the past four decades, the team has performed interactive shows in 3,000 villages changing mindsets, gently but firmly.

Climate change risks may hurt global economy

Climate change at the current pace can bring in unmitigated disaster, as global economy could shrink sharply

Taiwan, considered as the world's chip factory, has for long been the major source of electronic chips used in a wide variety of products ranging from mobile phones to high end cars. The importance of Taiwanese chip manufacturing on the global centre stage can be gauged by the fact that the recent trip by Nancy Pelosi to Taiwan included her meeting with Mark Lui, chairman of the Taiwan Semiconductor Manufacturing Corporation (TSMC).

Pelosi's trip coincided with the US efforts to convince TSMC – the world's largest chip manufacturer, on which the US is heavily dependent – to establish a manufacturing base in the US and to stop making advanced chips for Chinese companies.

But all has not been well for Taiwan. Besides the Chinese threats, the small island nation has been at the receiving end of one of the worst droughts seen in the last five years on account of inadequate Monsoons and now rare typhoons. Given the fact that chip factories are water guzzlers, this drought has triggered production cuts due to water scarcity and sent shockwaves across the world supply chain for chips. This shortage severely impacted global industry, especially the automotive sector and resulted in frozen delivery schedules, as vehicle inventory could not be forwarded to the dealers.

The rapidly worsening climate change conditions have played a key role in the above instance and if the report by Swiss Re Institute is to be considered, the larger impact of climate change could wipe out 18 per cent of GDP of the global economy by 2050 if global temperatures rise by 3.2°C. The Swiss Re Institute forecast is based on temperature increases staying on the current trajectory and the Paris Agreement and net-zero emissions targets not being met. The Institute warns in its report that climate change is a systemic risk that must be addressed immediately, but unfortunately the adverse impacts of climate change on the global economy are already evident.

The spectre of rising global temperatures as predicted by The Swiss Re Institute report seems to be coming true considering the increasing heat waves across the world, especially in the West where tem-

peratures of 40 degree Celsius were hitherto unheard of but are a reality today. The United Kingdom for instance recently experienced searing hot days that saw traffic signals and road surfaces melting. The spiralling temperatures aided by climate change are not only impacting the economy and industrial output, but are also extracting a huge cost from the global agricultural sector. Europe especially is experiencing stiff price hikes of food items due to falling food production in the face of unfavourable farming conditions arising out of erratic Monsoons and punishing summers.

The Indian economy too is seemingly fighting a losing battle with climate change. It is

projected that climate change is poised to erode India's GDP by 2.6 per cent by 2100 even if the global temperature rise is held below 2°C. In a scenario where global temperatures breach 3.2°C the GDP erosion is projected to be 13.4 per cent. Despite this grim reality, it is noteworthy that India is not responsible for rising temperatures despite having 17.8 per cent of the world's population. It accounts for only 3.2 per cent of cumulative emissions. However, the crossing of paths between economic progress and climate change is unavoidable as many aspects of the economic development are interlaced with the wellbeing of the environment in the absence of which economic growth is adversely impacted.

The major manifestation of

climate change playing with the economy in India is in the form of dwindling rainfall. The Indian Summer Monsoon (ISM) has a major influence on agriculture, water resources, human health and ecosystems, which in turn ensure a robust economy. However, of late the ISM has seen erratic patterns of either excessive rainfall to the point of triggering devastating floods or scanty rainfall resulting in droughts. This manifestation has indeed put the Indian economy in a tight spot and unless remedial measures are undertaken to dial down emissions and ambient temperatures, the economy can incur irreversible sectoral losses in the form of \$ 1.5 trillion per year.

Today, India and the world are moving from climate

change to climate emergency. India must hasten to protect those vulnerable sectors of the economy that are exposed to the vagaries of climate change. Sectors such as services, retail, tourism and construction require urgent protective measures as these account for over 80 per cent of the GDP of India. As a first step, the "silo" approach needs to be dispensed with and instead an integrated strategy that combines policy making with technology needs to be adopted. Additionally, compelling financing models need to be designed for climate action projects, thereby putting climate change mitigation on centre stage in India. These efforts will undoubtedly insulate the economy against climate change and enable India

US: Russia to buy rockets, artillery shells from North Korea

The Russian Ministry of Defence is in the process of purchasing millions of rockets and artillery shells from North Korea for its ongoing fight in Ukraine, according to a newly downgraded U.S. Intelligence finding.

A U.S. Official, who spoke on the condition of anonymity to discuss the intelligence determination, said Monday that the fact Russia is turning to the isolated state of North Korea demonstrates that “the Russian military continues to suffer from severe supply shortages in Ukraine, due in part to export controls and sanctions.”

U.S. Intelligence officials believe that the Russians could look to purchase additional North Korean military equipment in the future. The intelligence finding was first reported by The New York Times.

The U.S. Official did not detail

how much weaponry Russia intends to purchase from North Korea.

The finding comes after the Biden administration recently confirmed that the Russian military in August took delivery of Iranian-manufactured drones for use on the battlefield in Ukraine.

The White House said last week that Russia has faced technical problems with Iranian-made drones acquired from Tehran in August for use in its war with Ukraine.

Russia picked up Mohajer-6 and Shahed-series unmanned aerial vehicles over several days last month as part what the Biden administration says is likely part of a Russian plan to acquire hundreds of Iranian UAVs for use in Ukraine.

North Korea has sought to tighten relations with Russia as much of Europe and the West has pulled away, blaming the United States for the Ukraine crisis and decrying the West’s “hegemonic policy” as justifying military action by Russia in Ukraine to protect itself.

The North Koreans have hinted interest in sending construction workers to help rebuild Russian-occupied territories in the country’s east.

North Korea’s ambassador to Moscow recently met with envoys from two Russia-backed separatist



territories in the Donbas region of Ukraine and expressed optimism about cooperation in the “field of labor migration,” citing his country’s easing pandemic border controls.

In July North Korea became the only nation aside from Russia and Syria to recognize the independence of the territories, Donetsk and

Luhansk, further aligning with Russia over the conflict in Ukraine. The provocative move by North Korea comes as the Biden administration has become increasingly concerned about stepped-up activity by North Korea in pursuit of nuclear weapons.

North Korea has test-fired more than 30 ballistic missiles this year, including its first flights of intercontinental ballistic missiles since 2017, as leader Kim Jong Un pushes to advance his nuclear arsenal despite U.S.-led pressure and sanctions.

The U.S. Has frequently downgraded and unveiled intelligence findings over the course of the grinding war in Ukraine to highlight plans for Russian misinformation operations or to throw attention on Moscow’s difficulties in prosecuting the war. Ukraine’s smaller military has put up a stiff resistance against the militarily superior Russian forces.

Russian President Vladimir Putin and Kim have recently exchanged let-

ters in which they both called for “comprehensive” and “strategic and tactical” cooperation between the countries. Moscow, for its part, has issued statements condemning the revival of large-scale military exercises between the United States and South Korea this year, which North Korea views as an invasion rehearsal.

Russia, along with China, has called for the easing of U.N. Sanctions imposed on North Korea over its nuclear and missile tests. Both countries are members of the U.N. Security Council, which has approved a total of 11 rounds of sanctions on the North since 2006. In May, Russia and China vetoed a U.S.-led bid to impose new economic sanctions on North Korea over its high-profile missile tests this year.

Some experts say that Kim could likely bolster his resolve to retain his nuclear weapons because he may think the Russian attack happened because Ukraine had signed away its

nuclear arsenal.

Relations between Moscow and Pyongyang go back to the 1948 foundation of North Korea, as Soviet officials installed young, ambitious nationalist Kim Il Sung, the late grandfather of Kim Jong Un, as the country’s first ruler. Since then, Soviet aid shipment had been crucial in keeping North Korea’s economy afloat for decades before the disintegration of the Soviet Union in the early 1990s.

Moscow had since established formal diplomatic relations with Seoul as part of its hopes to draw South Korean investment and allowed its Soviet-era military alliance with North Korea to expire. But after his election in 2000, Putin actively sought to restore his country’s ties with North Korea in what was seen as an effort to regain its traditional domains of influence and secure more allies to better deal with the United States.

Fears grow for Ukraine nuke plant ahead of inspector report

Fears grew on Tuesday for Europe’s largest nuclear power plant as shelling around it continued, a day after the facility was again knocked off Ukraine’s electricity grid and put in the precarious position of relying on its own power to run safety systems.

Repeated warnings from world leaders that fighting around the Zaporizhzhia plant has put it in an untenable situation that could lead to a nuclear catastrophe have done little to stem the hostilities.

Russian-installed officials accused the Ukrainian forces of shelling the city where the plant is located on Tuesday, hours after the Ukrainians said Kremlin forces attacked a city across the river.

Both sides have traded such accusations as Russian troops seized the plant early in the war.

With the danger rising, an International Atomic Energy Agency team finally traveled to the plant last week, and inspectors are expected to report what



they found to the UN Security Council later in the day.

Two inspectors remain at the plant, which is run by Ukrainians workers, and Ukrainian presidential adviser Mykhailo Podolyak applauded that decision.

“There are Russian troops now who don’t understand what’s happening, don’t assess the risks correctly,” Podolyak said.

“There is a number of our workers there, who need some kind of protection, people from the international community standing by their side and telling (Russian troops): Don’t touch

these people, let them work.”

But that appears to have done little to lessen the risks. On Monday, the IAEA said Ukrainian authorities reported that the plant’s last transmission line was disconnected to allow workers to put out a fire caused by shelling.

“The line itself is not damaged, and it will be reconnected once the fire is extinguished,” the IAEA said.

In the meantime, the plant’s only remaining operational reactor would “generate the power the plant needs for its safety and other functions,” the agency said.



Putin attends joint military drills with China, others

Russian President Vladimir Putin on Tuesday attended sweeping war games in his country’s far east involving troops from China and other nations, in a show of military muscle amid the tensions with the West over Moscow’s action in Ukraine.

The weeklong exercise that began Thursday is intended to showcase growing defense ties between Russia and China and also demonstrate that Moscow has enough troops and equipment to conduct the massive drills even while its forces are engaged in fighting in Ukraine.

The Russian Defense Ministry said that the Vostok 2022 (East 2022) exercise that runs until Wednesday at seven firing ranges in Russia’s Far East and the Sea of Japan involves more than 50,000 troops and over 5,000 weapons units, including 140 aircraft and 60 warships. It engages troops from several ex-Soviet nations, China, India, Laos, Mongolia, Nicaragua and Syria.

Beijing sent more than 2,000 troops along with more than 300 military vehicles, 21 combat aircraft and three warships to take part in the drills, according to Chinese news reports. As part of the maneuvers, the Russian and Chinese navies in the Sea of Japan practiced joint action to protect sea communications and support for ground forces in coastal areas.

The exercise marked the first time that China has sent forces from three branches of its military to take part in a single Russian drill, a sign of increasing close ties between Moscow and Beijing, which have grown stronger since Putin sent his troops into Ukraine on Feb. 24. China has pointedly refused to criticise Russia’s actions, blaming the U.S. And NATO for provoking Moscow, and has blasted the punishing Western sanctions against Russia.

‘US to work with partners in South Asia to address climate crisis’

A top American diplomat on Tuesday said that the US is dedicated to working together with its partners throughout South Asia to address the climate change crisis.

The US government’s Acting Principal Deputy Assistant Secretary for South and Central Asian Affairs Elizabeth Horst said this during the first Climate Action Champions Network Conference here.

She arrived here on Tuesday on a brief visit to Nepal to attend the conference during which 100 young leaders from Bangladesh, Bhutan, India, Nepal and Sri Lanka developed action plans to face the numerous challenges that climate change brings.

“During her visit, Horst will focus on our partnership on climate change and attend the first ever Climate Action Champions Network Conference,” US Embassy had said earlier in its Facebook page.

Addressing the conference, Horst spoke about the need for urgency and unity to fight the



climate crisis.

“Climate change hurts communities, and the United States is dedicated to working together with our partners throughout South Asia to address this critical crisis,” Horst said.

The Climate Action Champions Network aims to harness the potential of the youth in the region by bringing together 100 individuals from the countries of Bangladesh, Bhutan, India, Nepal, and Sri Lanka, over 30 months to discuss and deliberate about creating a climate action vision for South Asia and the Indo-Pacific, according to website of the Conference.

Typhoon batters S Korea, preparations cut casualties

The most powerful typhoon to hit South Korea in years on Tuesday dumped a metre (3 feet) of rain, destroyed roads and fell power lines, but the death toll of three could have been higher if not for proactive evacuations and closures of schools, officials said.

There was also greater public awareness about the storm and its risks. Typhoon Hinnamnor made impact just weeks after heavy rains around the capital Seoul caused flooding that killed at least 14 people.

Government officials had put the nation on high alert for days as Hinnamnor approached, warning of potentially historic destruction and putting in motion life-saving measures.

After grazing the resort island of Jeju and hitting the mainland near the port city of Busan, Hinnamnor weakened as it blew into waters between



the Korean Peninsula and Japan.

South Korea’s weather agency said Hinnamnor was over the open sea 280 kilometres (173 miles) northeast of Ulleung island with winds weakened to 115 kilometres (71 miles) per hour on Tuesday afternoon.

It was expected to be downgraded to a tropical cyclone by night as it moves northeast between Russia and the northern Japanese island of Hokkaido, the agency said.

However, the damage was still severe in the southern city

of Pohang, where two people were found dead and at least seven others were missing after the storm submerged roads and buildings, triggered landslides and flooded a shopping mall.

Cars with smashed windows and trunks open lay scattered on roads like garbage. An entire two-story pool villa was uprooted from the ground and swept away in flash floods.

Troops were deployed to assist with rescue and restoration efforts, moving in armored vehicles rolling through streets that turned into chocolate-coloured rivers.

Firefighters navigated flooded neighbourhoods in rubber boats, rescuing people and their pets.

Merchants scrambled to salvage furniture and other belongings at the famous Guryongpo outdoor market, where workers deployed excavators to clear huge piles of debris.



Earthquake kills 65, triggers landslides in southwest China

The powerful earthquake that set off landslides and shook buildings in southwestern China killed at least 65 people and injured hundreds, state media said Tuesday.

At least 16 other people are missing a day after the 6.8 magnitude earthquake struck a mountainous area in Luding county in Sichuan province, which sits on the edge of the Tibetan Plateau where tectonic plates meet and is hit regularly by quakes. The tremor shook buildings in the provincial capital of Chengdu, whose 21 million residents are already under a COVID-19 lockdown.

Power was knocked out and buildings damaged in the historic town of Moxi in the Tibetan autonomous prefecture of Garze, where 37 people were killed. Tents were erected for more than 50,000 people being moved from homes made unsafe by the quake, the official Xinhua News Agency reported.

State broadcaster CCTV showed rescue crews pulling a woman who appeared uninjured from a collapsed home in Moxi, where many of the buildings are constructed from a mix of wood and brick. Around 150 people were reported with varying degrees of injuries.

Another 28 people were killed in neighbouring Shimian county on the outskirts of the city of Ya’an. Another 248 people were reported as injured, mainly in Moxi, and another 12 people were reported missing.

Taiwan leader cites threat of Chinese ‘cognitive warfare’

Taiwanese President Tsai Ing-wen said Tuesday “cognitive warfare” by spreading misinformation in addition to its regular incursions into nearby waters and airspace intended at intimidating the self-governing island.

Experts have warned that China has made substantial inroads within Taiwanese mass media and could plant false narratives in social media and elsewhere to erode military morale and public confidence in the event it makes good on its threat to use force to take control of the island it claims as its own territory.

“The situation around the Taiwan Strait continues to be tense, and the threat has never ceased,” Tsai said in a speech during a visit to an air defense



and missile battalion in the eastern country of Hualien.

“In addition to frequent intrusions by China’s aircraft and ships, China also conducted cognitive warfare, using false information to create disturbance in minds of people,” the president said.

Tsai also referenced China’s use of drones “to increase pressure on Taiwan’s military,” following incidents in which Taiwanese troops based on islands just off the Chinese coast warned off and in once case, shot down unmanned aerial vehicles that had been

hovering over their positions.

Anti-drone defenses are included in a 12.9% increase in Taiwan’s budget for next year. The rise will increase total spending to \$13.8 billion, or roughly 2.4% of GDP.

Taiwan on Tuesday was also launching military exercises on the Hengchun Peninsula in the far south of the island simulating ground warfare against an invading enemy, aided by Apache attack helicopters.

Alongside promoting Taiwan’s high-tech economy, Tsai has made strengthening the island’s defenses a key feature of her second and last four-year term in office. That includes bulking up the domestic defense industry as well as procuring more weaponry from the U.S., including fighter jets and missiles, to resist a Chinese attack or attempted blockade.

Lanka SC OK’s more power to Parliament over President

Sri Lanka’s Supreme Court has ruled that the Bill seeking the 22nd amendment to the Constitution can be adopted with a two-thirds majority in Parliament and some clauses requiring a nationwide referendum, the Parliament Speaker announced on Tuesday.

The draft bill on the 22nd amendment, aimed at empowering Parliament over the executive president, was approved by the country’s Cabinet and gazetted last month. The 22nd amendment was originally named 21A and meant to replace the 20A.

The amendment was formulated amid the ongoing economic turmoil in the country which also caused a political crisis. It is meant to replace the 20A that had given unfettered powers to ex-President Gotabaya Rajapaksa after abolishing the 19th Amendment.

Speaker of Parliament Mahinda Yapa Abeywardene said the 22nd amendment to the Constitution can only be adopted with a two-thirds majority in Parliament and a nationwide referendum on clauses 2 and 3 of the bill that are inconsistent with the Constitution.

The apex court recommended changes to help Parliament pass the bill with only a special majority. The bill aims to restore independent



commissions and also curbs some of the powers of the president.

Interested parties were given time to petition the Supreme Court. The court determination was received by Parliament on Tuesday. There were 10 such petitions filed.

The 22A was meant to undo the 20A adopted in 2020 which restored full executive powers to then-President Gotabaya Rajapaksa. Rajapaksa had reversed through 20A the features of the 19A which had empowered Parliament over the presidency.

Rajapaksa was ousted in mid-July through the popular uprising against him for mishandling the country’s economy.

Foreign minister Ali Sabry said on Monday that the 22A would be presented in Parliament very soon for approval.

35 killed as roadside bomb hits convoy in Burkina Faso

AP ■ OUAGADOUGOU (BURKINA FASO)

A suspected jihadi roadside bomb has hit a convoy in northern Burkina Faso, killing at least 35 people and injuring dozens more. The supply convoy escorted by the army was hit Monday while driving between Bourzanga and Djibo towns with one of the vehicles carrying civilians, the governor of Sahel region, Lt Col Rodolphe Sorgho, said in a statement.

The wounded have been evacuated and the area of the explosion has been secured, he said. Although no group immediately claimed responsibility for the bomb, it is suspected to be by Islamic extremist rebels. Burkina Faso has been ravaged by violence linked to al-Qaida and the Islamic State group in which thousands have been killed.

This is the fifth explosion in Soum province since August, particularly around Djibo, which has been under siege by jihadis for months, according to an internal security report for aid workers seen by The Associated Press. A double explosion last month between Djibo and Namssiguia killed at least 15 people, said the report. A military coup in January ousted the



country’s democratically elected government claiming they could better secure the country from the extremists.

Monday’s attack comes one day after interim President Lt. Col. Paul-Henri Sandaogo Damiba spoke to the nation saying the junta had achieved some progress in pushing back the jihadis. “We have made many efforts since we came to power ... Our efforts have begun to bear fruit at the military operational level,” he said.

This latest attack, however, damages the credibility of Damiba’s claim, say analysts.

“Aside from the staggering casualty toll, the timing of the incident is unfortunate, given that only two days ago President Damiba made a speech in an attempt to convince the public that the country was making progress,” said Henri Nsaibia, senior researcher at the Armed Conflict Location and Event Data Project.

‘Rajapaksas and friends thought they owned Lanka’

Sri Lanka’s former president Chandrika Kumaratunga on Tuesday blamed the Rajapaksas family for the country’s current economic crisis, saying they and their friends thought they owned the nation and its assets and could get away with anything.

Kumaratunga, Sri Lanka’s first and only female president to date, said actions taken by the Rajapaksas regimes had led to a serious crisis situation in the country.

“Not only the Rajapaksas, but the government representatives around them, their friends, and associates are also to be blamed for the prevailing crisis,” the Daily Mirror, an online newspaper quoted the 77-year-old Kumaratunga as saying.

Her remarks came during the opening of the new office of the ‘Nawa Lanka Freedom Party’ in Battaramulla. The party is led by former minister and Kalutara District parliamentarian Kumara Welgama.

Kumaratunga said that the Rajapaksas and those who ruled the country after 2005 had thought they owned the country and its assets.

Queen Elizabeth II appoints Truss as Britain’s new PM

Conservative Party leader Liz Truss was on Tuesday appointed as Britain’s new Prime Minister - the third female premier of the country - amid pressure to tackle the looming energy crisis and soaring prices.

Truss travelled to Queen Elizabeth II’s Balmoral Castle residence in Aberdeenshire, Scotland, to meet the 96-year-old monarch. Earlier, Boris Johnson formally resigned as the head of the UK government in an audience with the Queen.

The 47-year-old leader is the 15th Prime Minister to serve during Queen Elizabeth II’s reign, the first being Winston Churchill in 1952.



Until now, the constitutional process of the monarch inviting the leader of the majority party to form a government in her name has taken place at Buckingham Palace in London. But with the Queen cutting back on her travels, it had been decided that she would receive

Johnson and Truss at her summer residence of Balmoral Castle in Aberdeenshire, Scotland, marking a historic first.

“The Queen received in Audience The Right Honourable Elizabeth Truss MP today and requested her to form a new

Administration. Ms Truss accepted Her Majesty’s offer and kissed hands upon her appointment as Prime Minister and First Lord of the Treasury,” a royal announcement confirmed.

A picture of the Queen and Truss showed them meeting in the drawing room of Balmoral in front of an ornate fireplace. The smiling monarch, who was wearing a tartan skirt and holding her walking stick, was pictured shaking hands with Truss – symbolically referred to as kissing hands.

Truss assumed the office at a time when the country is facing a looming energy crisis and the focus is on her plan to address the challenge.

Commerce and Industry Minister Piyush Goyal has pitched India as the best investment destination, saying the time is "just ripe" to engage in areas of mutual interests of India and the US.

Addressing industry leaders of the US and India here, the minister on Monday said both countries can promote global security, stability and resilient supply chains.

"There are many competi-

tive advantages that the US-India relation has to offer. The resilience of our supply chains and the way talent India has provided to the US and invest-ments the US has provided to India, all of these cumulatively make a very good business case," he said while addressing the US India Strategic Partnership Forum (USISPF).

He added that India provides best investment opportunity.

"It is a destination you cannot miss. It is a market of a



billion plus aspirations," Goyal said.

Inviting US businesses to invest in India, the minister said the time is just ripe for "all of us to engage in areas of mutual interest."

Foreign direct investment equity inflows into India stood at USD 16.59 billion during April-June this fiscal year as against USD 17.56 billion in the same period last year.

According to an official statement released in May, India recorded "highest" ever

annual FDI inflow of USD 83.57 billion in 2021-22.

The government reviews the FDI policy on an ongoing basis and makes significant changes from time to time, to ensure that India remains attractive and investor-friendly destination.

FDI norms have been eased in several sectors such as coal mining, contract manufacturing, digital media, single brand retail trading, civil aviation, defence, insurance and telecom.



Airlines count on business travellers to keep recovery going

With summer vacations winding down, airlines are counting on the return of more business travellers to keep their pandemic recovery going into the fall.

Air travel in the United States, bolstered by huge numbers of tourists, has nearly recovered to pre-pandemic levels.

Inflation - and especially this year's sharp rise in airfares - raises concern about how long vacationers can afford to keep flying at their current pace. Airlines say they see no signs of a slowdown in leisure travel.

Business travel, however, remains about 25% to 30% below 2019 levels, according to airlines and outfits that track sales.

And it is not clear when - or if - road warriors will return to their old travel habits.

"The whole challenge for the industry is around the return of the corporate traveler, and whether he is going to come back in enough volume and frequency that is going to help these airlines," says John Grant, an analyst with travel-data provider OAG.

The Global Business Travel Association recently predicted

that corporate travel won't fully return until mid-2026, 18 months later than the trade group had previously forecast.

Business travelers generally pay higher fares, so their absence has an outsized impact on airline revenue and profit.

Business travel is slower to return because it is more complicated than somebody deciding they want to take a vacation after staying home during the first two years of the pandemic, says Chuck Thackston, who leads data research at the Airlines Reporting Corp., a ticket-settlement firm that operates as a middleman between airlines and travel agents.

"On the corporate side, it just takes a little more to restart that because there are so many moving parts," Thackston said. "If you want to go visit clients in New York, it could be that nobody is in the office in New York. That is slowly building back." Conventions and other big meetings are another key driver of business travel, and also seem to be coming back, Thackston said.

Airline officials say that travel by small-business operators has recovered nearly fully, but that many corporate travelers have not returned to the road or skies.

Govt sets up Kirit Parikh committee to moderate gas prices

The government has set up a panel to review the formula that dictates the pricing of gas produced by companies like ONGC and Reliance as it looks to moderate the steep increase that producers would have otherwise got.

The committee under former planning commission member Kirit S Parikh will suggest a "fair price to the end consumer", according to an order of the oil ministry.

The panel, which will include representatives of the gas producers association as also producers ONGC and OIL, has been asked to submit its report by the month-end.

It also has a member from private city gas operators, state gas utility GAIL, a representative of Indian Oil Corporation (IOC) and a member from the fertiliser ministry, the order

said.

The government had in 2014 used prices in gas surplus countries to arrive at a formula for locally produced gas. The rates according to this formula were subdued and at times lower than the cost of production till March 2022 but rose sharply thereafter, reflecting the surge in global rates in the aftermath of Russia's invasion of Ukraine. The prices, which are payable to producers like Reliance Industries as well as state-owned Oil and Natural Gas Corporation (ONGC) are due for revision on October 1 and are expected to go up further.

The price of gas from old fields, which are predominantly of state-owned producers like ONGC and Oil India Ltd, was more than doubled to USD 6.1 per million British thermal unit from April 1 and is expected to cross USD 9 next month.

Over 52 pc gig workers feel work environment makes it difficult to upskill, find new jobs: Report

Over 52 per cent of gig workers or contract employees feel that their work environment makes it challenging for them to upskill or find new job opportunities, according to a report.

According to the report by CII.CO, a startup platform built at Indian Institute of Management (IIM) Ahmedabad, most young respondents increasingly look towards gig economy platforms for their first jobs. However, over 52 per cent of gig workers said the gig working environment makes it difficult to upskill or find new job opportunities, it added.

The report further analysed that gigs offered by platforms initially hook individuals with the opportunity of short-term income but keep them employed for prolonged periods of time in a career without a long-term growth trajectory.

"Only about one in three individuals we spoke to had clear plans for shifting jobs in the near future. This was despite the vast majority reportedly working overtime in their current shifts and having no resources for up-skilling at the jobs they held," said the report.

This skills gap, however, has another



significant impact on the long-term growth of the economy, the report said, adding the data has revealed that platforms today are increasingly becoming the source of a first job for young graduates leaving university. If they are not upskilled and placed in good organisations with better income, it leads to underutilised human capital within the country, it stated.

The CII.CO report is based on a survey among 4,070 platform based gig workers, including the high earning knowledge workers and daily-wage agricultural workers.

The report further said that 50 per cent of platform workers today find their jobs through traditional referral networks despite 80 per cent having internet access.

"In many ways, gig workers are channels through which the old and new India interact. We're in 2022, it is about time that each of us has access to our own data. Enabling gig workers to own and use their employment, financial, health etc. Data will improve their well-being and unlock the growth of both traditional and new economies," CII.CO Partner - Insights Supriya Sharma said.

Benchmarks settle modestly lower in volatile trade

The Sensex and Nifty closed modestly lower on Tuesday after investors offloaded FMCG, IT and banking stocks in the last hour of trade amid mixed global cues.

After rising over 320 points in intra-day trade, the 30-share BSE Sensex pared all gains to settle 48.99 points or 0.08 per cent lower at 59,196.99.



On similar lines, the broader NSE Nifty slipped 10.20 points or 0.06 per cent to 17,655.60.

Bajaj Finserv was the top laggard in the Sensex pack, dropping 2.08 per cent, followed by Kotak Mahindra Bank, HUL, M&M, Bajaj Finance, Nestle India and Asian Paints.

On the other hand, Bharti Airtel, NTPC, Tata Steel, Reliance Industries, Power Grid, Dr Reddy's and Sun Pharma were among the major gainers, spurring as much as 2.79 per cent.

The market breadth was negative, with 20 of the 30 Sensex components closing in the red. "Domestic indices wiped out early gains to close flat, tracking mixed global cues. While the energy crisis and ECB interest rate decision later in the week pressurised European markets, Chinese policymakers' renewed efforts to strengthen its economy boded well for the Chinese bourses.

"In an effort to stabilize declining oil prices, OPEC+ opted to cut back on the output given the faltering global growth outlook," said Vinod Nair, Head of Research at Geojit Financial Services.

Irish regulators fine Instagram 405mn euros for data breach

Irish regulators are slapping Instagram with a big fine after an investigation found the social media platform mishandled teenagers' personal data. Ireland's Data Protection Commission said by email Monday that it made a final decision last week to fine the company 405 million euros (\$402 million), though the full details won't be released until next week. The penal-

ty is the second-biggest issued under the European Union's stringent privacy rules, after Luxembourg's regulators fined Amazon 746 million euros last year.

Instagram parent Meta, which also owns Facebook and can appeal the decision, didn't respond to a request for comment.

The Irish watchdog's investigation centered on how Instagram exposed the personal details of users ages 13 to 17.

Adani group says not overleveraged, loans from public banks halved

Richest Indian Gautam Adani's Rconglomerate has cited an improved net debt to operating profit ratio and more than halving of loans from public sector banks to allay concerns about it being overleveraged.

In a 15-page note in response to CreditSights report calling the group overleveraged, it said companies in the group have consistently de-levered, with the net debt to Ebitda ratio declining to 3.2 times from 7.6 times in the last nine years.

"The businesses operate on a sim-



ple yet robust and repeatable business model focused on development and origination, operations and management and capital management plan," the note, reviewed by PTI, said. The group had a gross debt of Rs

1.88 lakh crore in March 2022 and net debt of Rs 1.61 lakh crore after considering the cash balance.

While loans from public sector banks in 2015-16 accounted for 55 per cent of all debt of the group firms, in 2021-22, borrowing from PSBs made up for 21 per cent of all debt, it said.

In FY2016, private banks accounted for 31 per cent of loans, which has now shrunk to 11 per cent. Money raised through bonds has jumped from 14 per cent of all loans to account for 50 per cent now.

In a report titled 'Adani Group: Deeply Overleveraged', CreditSights,

a Fitch group firm, had last month stated that the ports-to-power-to-cement conglomerate is "deeply overleveraged" with the group predominantly using debt to invest aggressively across existing as well as new businesses. "In the worst-case scenario, overly ambitious debt-funded growth plans could eventually spiral into a massive debt trap, and possibly culminate into a distressed situation or default of one or more group companies," it had said.

Adani, 60, has in the last few years expanded his coal-to-ports conglomerate into airports, data centres, cement, aluminium and city gas.

Insurance claims independent of human errors: Industry players

The death of former Tata group chairman Cyrus Mistry in a road accident has ignited a debate over the eligibility of insurance claims in accident cases but industry players say the very purpose of buying insurance is to hedge against risk, whether due to human error or otherwise. Human error or violation of rules is unlikely to vitiate an insurance policy and accidental death claims will continue to be honoured albeit in exceptional cases the compensation amount may be lowered.

However, most policies mention "any accidental loss or damage suffered whilst the insured or any person driving the vehicle with the knowledge

Cooperating with authorities probing Mistry car crash: Mercedes-Benz India

Luxury carmaker Mercedes-Benz India on Tuesday said it is cooperating with the authorities investigating the car crash that led to the death of former Tata Sons chairman Cyrus Mistry.

Mistry (54) and his friend Jahangir Pandole were killed on Sunday afternoon when their Mercedes GLC 220d 4MATIC car hit a road divider in Palghar district of Maharashtra.

Two other car occupants -

- Anahita Pandole (55), who was at the wheel, and her husband Darius Pandole (60) -- suffered injuries and are admitted to a private hospital in Mumbai.

Mistry was cremated on Tuesday. The last rites were performed in an electric crematorium at Worli in central Mumbai.

"As a responsible brand respecting customer privacy, our team is cooperating with the authorities where possible, and we will provide any clari-

fications to them directly as required," the automaker said in a statement.

The German auto major noted that it would continue ongoing efforts to increase road safety awareness as a responsible manufacturer while equipping its vehicles with the latest safety features and technologies.

"We are deeply saddened by the untimely demise of Cyrus Mistry and Jahangir Pandole in the unfortunate road accident.

speeding and an "error of judgement" by the driver to have led to the accident."Majority of the accidents happen because of human negligence. We are here because such human errors happen, if such human errors didn't happen, then very less number of accidents will happen. One buys a policy which actually covers his/her negligence.

"But our emphasis is always on safety. We keep on educating the customers about their safety and sensitise them through sustained campaigns because an insurance cover can only compensate for the financial loss but not for the loss of human life," Sanjay Datta, Chief - Underwriting & Claims, ICICI Lombard General Insurance Company, said. Insurance companies cover the claims arising out of human error or negligence, for example, one may even sustain an injury while cooking at home or there may be a fire incident, he added.

SER clocks nearly 27pc growth in coal loading in first 5 months of FY23

The South Eastern Railway (SER) has registered nearly 27 per cent growth in coal loading in the first five months of the 2022-23 fiscal, an official said here on Tuesday.

Revenue generation of SER from "originating freight" loading has also increased to Rs 7,039.60 crore during the April-August period of the 2022-23 financial year (FY23) as against Rs 6,646.93 crore in the corresponding months last fiscal.

The Kolkata-headquartered zonal railway has loaded 81.83 million tonne of "originating freight" in the first five months of FY23, of which coal constitutes 21.10 million tonne, the official said. This is "26.65 per cent higher than the coal loading done by the SER during the same period last year", he said.

The main commodities of freight loading, apart from coal, are iron ore, pig iron, finished steel, cement and petroleum products, the official added.

Global stocks rise as Europe wrestles with gas shortage

Global stock markets and Wall Street futures rose Tuesday as Liz Truss prepared to become British prime minister and Europe wrestled with uncertainty about Russian gas supplies.

London and Frankfurt opened higher. Shanghai and Tokyo gained. Benchmark US crude rose more than \$2 per barrel. The euro edged higher against the dollar.

European markets were jolted by Friday's announcement that the suspension of Russian gas supplies through the Nord Stream 1 pipeline would be extended indefinitely. Shortages have pushed up prices and weigh on economic growth.

Truss "will have to hit the

ground running as the U.K. Prepares for a brutal winter," Craig Erlam of Oanda said in a report. Noting news reports that Truss plans to freeze energy bills, Erlam said "the question is what impact it will have on inflation and gas demand."

In early trading, the FTSE 100 in London rose 0.3% to 7,307.22 and Frankfurt's DAX advanced 0.4% to 12,816.01. The CAC 40 in France gained 0.2% to 6,103.77.

On Wall Street, futures for the S&P;P 500 index and the Dow Jones Industrial Average were up 0.5% as U.S. Markets prepared to reopen after a three-day holiday weekend.

On Friday, the S&P;P and the Dow both lost 1.1% after government data showed U.S. Hiring



slowed in August but wages rose. Forecasters said the Federal Reserve might see that as evidence more rate hikes are needed to cool inflation that is at a multi-decade high. Investors worry repeated rate

hikes by the Fed and central banks in Asia and Europe to control surging inflation might derail global economic growth. Central banks say they must slow business and consumer activity to get prices under control.

In Asia, the Shanghai Composite Index rose 1.4% to 3,243.44 after the government promised Monday to accelerate easier lending and other policies to shore up economic growth that sank to 2.5% over a year earlier in the first half of 2022, less than half the official annual target.

The announcement might "provide a short-term uplift" to sentiment, but investors "ultimately want to see a stronger recovery," said Yeap Jun Rong of IG in a report.

SEBI calls for information on unclaimed non-convertible securities by September 15

Capital markets regulator Sebi on Tuesday asked all entities which have listed non-convertible securities to submit information pertaining to unclaimed redemption and dividend amounts by September 15.

The information has been sought from all the entities which do not fall within the definition of 'company' under the Companies Act and which had listed non-convertible securities, including non-convertible debt securities, non-convertible redeemable preference shares and perpetual non-cumulative preference shares and perpetual debt instruments, according to a public notice. Also, information has been sought from those who have unclaimed interest, dividend, principal and redemption amount on such instruments as on August 31.

FinMin releases 6th instalment of revenue deficit grant of ₹7,183 cr to 14 States

The finance ministry on Tuesday released the sixth instalment of revenue deficit grant of Rs 7,183 crore to 14 states for the current fiscal.

The states for which the Post Devolution Revenue Deficit (PDRD) grant has been recommended by the 15th Finance Commission during 2022-23 are -- Andhra Pradesh, Assam, Himachal Pradesh, Kerala, Manipur, Meghalaya, Mizoram, Nagaland, Punjab, Rajasthan, Sikkim, Tripura, Uttarakhand and West Bengal.

"The Department of Expenditure has on Tuesday

released the 6th monthly instalment of Post Devolution Revenue Deficit (PDRD) Grant of Rs 7,183.42 crore to 14 states," the ministry said in a statement.

The 15th Finance Commission has recommended a total PDRD grant of Rs 86,201 crore to 14 states for the financial year 2022-23. The grant is released in 12 equated monthly instalments.

The ministry said with the release of the sixth instalment for the month of September 2022, the total amount of PDRD grants released to the states in 2022-23 stands at Rs 43,100.50 crore.

TIAFOE SENDS NADAL CRASHING OUT

AP ■ NEW YORK

Frances Tiafoe of the United States produced the performance of a lifetime to send Rafael Nadal crashing out of the US Open in a stunning fourth round upset on Monday.

Tiafoe, who had only reached one major championship quarter-final in his career before, shattered Nadal's hopes of adding to his record collection of 22 Grand Slam singles titles with a 6-4, 4-6, 6-4, 6-3 victory.

A packed Arthur Ashe Stadium crowd roared in delight as the 24-year-old 22nd seed bombarded Nadal with 18 aces and 49 winners to seal victory in 3hr 34min.

The win sends Tiafoe into a last eight showdown against Russian ninth seed Andrey Rublev on Wednesday.

"I don't even know what to say right now," Tiafoe said after his superb victory. "I'm beyond happy, I'm almost in tears. I can't believe it."

"He's definitely one of the greatest of all time. I played unbelievable tennis today but yeah - I really don't know what happened."

Tiafoe, the son of immigrants from Sierra Leone who began playing tennis as a four-year-old when his father worked as a live-in caretaker at a tennis facility in Maryland, had never gone further than the fourth round at the US Open in seven previous appearances.

"When I first came on the scene a lot of people had expectations of me of how I would do and stuff, but I wasn't ready for it. Mentally I wasn't mature enough for those moments," Tiafoe said.

"But these last couple of years I've been able to put my head down and develop."

Nadal paid tribute to



Tiafoe's performance, and admitted he had struggled to cope with the American's tactic of moving him around the court.

"I played a bad match' "I played a bad match and he played a good match. At the end that's it, no?," Nadal said.

"Tennis is a sport of position a lot of times, no? If not, you

need to be very, very quick and very young. I am not in that moment anymore," the 36-year-old said.

EARLY MORNING EPIC

Carlos Alcaraz reached the US Open quarter-finals for a second successive year when he defeated 2014 champion Marin Cilic in an epic last-16 tie which

finished at 02:23 a.m. on Tuesday.

In a gruelling three-hour and 54-minute encounter, Cilic was under siege, having to save 12 of 18 break points while committing 66 unforced errors.

The 19-year-old Alcaraz, seeded three and seen as the title favorite after the elimination of four-time champion Rafael

Nadal, will face Jannik Sinner of Italy for a semi-final place.

Sinner holds a 2-1 advantage over Alcaraz with both wins coming this year at Wimbledon and Umag.

"I believed in myself, it was pretty tough," said Alcaraz.

"I was a break down in the fifth set. It was tough to come back after losing the fourth set."

SINNER INTO QFS

Earlier, Italy's Jannik Sinner reached a Grand Slam quarter-final for the third time this season after beating unseeded Ilya Ivashka in five sets.

The 11th seed squeezed past the 28-year-old Belarusian 6-1, 5-7, 6-2, 4-6, 6-3.

The Monaco-based 21-year-old has performed consistently well at Grand Slams this year, reaching quarter-finals at the Australian Open and Wimbledon, and the fourth round at the French Open.

RUBLEV DOWNS NORRIE

Andrey Rublev shrugged off a rain delay to breeze past Cameron Norrie and reach the quarter-finals for the third time.

The ninth-seeded Russian triumphed 6-4, 6-4, 6-4 and will face Frances Tiafoe of the United States for a place in the semi-finals.

"It was two and a half hours, it was tough," said 24-year-old Rublev who had needed four hours and five sets to get past Denis Shapovalov in the third round.

"Cameron and I, we have known each other for a long time. I knew I had to give my best."

"I played a good match. I was able to win in three sets so I am super happy,"

Rublev, who also made the last-eight in New York in 2017 and 2020.

I don't know when I'll be back, says Nadal

AP ■ NEW YORK

Rafael Nadal admitted on Monday that he wasn't sure when he will return to action after Frances Tiafoe condemned him to his earliest US Open exit since 2016.

For Australian and French Open champion Nadal, it was a first Grand Slam loss of 2022 after an abdominal strain forced him to forfeit his Wimbledon semi-final.

The defeat ended a run of 16 successive Slams where the Spaniard had made at least the quarter-finals.

"I need to go back. I need to fix things. I don't know when I going to come back," Nadal told a press conference.

"I going to try to be ready mentally. When I feel that I will be ready to compete again, I will be there."

Nadal has endured a rollercoaster year.

His two Slam titles have taken him one clear of Novak Djokovic but his physical frailties have also returned to haunt him.

Nadal suffered a stress fracture of the ribs in March before requiring daily pain-killing injections in his left foot to see him through to a 14th French Open title in June.

Then his bid for a third Wimbledon crown was shattered by an abdominal injury.



Nadal is due to become a father for the first time in the coming weeks, a factor which will factor heavily into his future on-court plans.

"Now I have to go home, I have more important things than tennis to attend to," he said.

"Decisions will be made based on how everything goes in my personal life, which comes before my professional life."

He added: "It's been a bit difficult for a few months but I want to finish the year with something very important that is my first child."

Nadal is scheduled to return to action at the Laver Cup in London from September 23. He has already qualified for the ATP Tour Finals in Turin to be staged in November.

Despite his doubts over his future plans, Nadal told Spanish media that he won't rule out playing again this year.

"I will do a mini pre-season to finish the year in Europe with good feelings and that is what we are going to try. There is a tournament ahead if everything else goes well," he said.



UEFA president confident Spain, Portugal will host 2030 WCup

UEFA president Aleksander Ceferin is certain Spain and Portugal will host the 2030 World Cup despite strong bidding competition from South America.

The Iberian nations agreed in 2020 to submit a proposal to stage matches in the World Cup's centenary year. However, a four-way bid from Argentina, Chile, Paraguay, and Uruguay is expected to be among 2030's top candidates given that the latter country hosted and won the inaugural World Cup in 1930.

"I am sure that the 2030 World Cup will be played in Spain and Portugal," Ceferin said.

"This bid is a winning one, and we will do everything possible to help two countries that are passionate, live and breathe football, and that have a good infrastructure."

Eleven Spanish venues are expected to be used for the 2030 tournament if the bid is successful, while Portugal will put three stadiums forward for consideration, Kallas reports.

Spain last staged a World Cup in 1982. Portugal has never hosted the prestigious competition but provided the venues for Euro 2004.

South America has held only one World Cup - Brazil in 2014 - within its shores since the 1978 edition in Argentina.

Vinicius takes ESP nationality

Brazil international Vinicius Junior has acquired Spanish nationality, his club Real Madrid announced on Monday, allowing the club to register another non-European Union player.

"Our Brazilian player Vinicius Junior took the oath of allegiance to the Spanish Constitution on Friday 2 September, so from that moment he also has Spanish nationality," said a Real Madrid statement.

World No. 1 Iga makes Polish victory

World number one Iga Swiatek became the first Polish woman to reach the US Open quarter-finals on Monday when she defeated Jule Niemeier in an error-strewn last-16 clash.

French Open champion Swiatek recovered from a set and a break down to see off her 108th-ranked German opponent, 2-6, 6-4, 6-0.

Top seeded Swiatek will face US eighth seed Jessica Pegula for a place in the semi-finals.

In a mistake-riddled clash on Louis Armstrong Court, there were a total of 15 double faults, 12 breaks of serve and 76 unforced errors.

"It's really satisfying. This is my first quarter-final in New York so I am really proud of it," said Swiatek.

Wimbledon quarter-finalist Niemeier hadn't won a hardcourt match in her career before coming to New York.

However, went into Monday's match not having dropped a set and fired up to repeat her Wimbledon journey where she had also beaten world number two Anett Kontaveit.

SABALENKA WINS

Aryna Sabalenka reached the US Open quarter-finals for a second successive year with a three-set comeback win over Danielle Collins.

The world number six from Belarus triumphed 3-6, 6-



3, 6-2 over her American opponent who she has now beaten in New York three times in the last five editions.

Sabalenka eventually fell at the semi-finals in 2021 and her 2022 bid looked in danger on Monday when she needed a medical time-out to treat a leg injury.

However, she eventually fought back from a set down against the Australian Open runner-up and sealed victory on the back of a double break in the decider.

PEGULA INTO LAST 8

Jessica Pegula became the second American woman into this year's US Open quarter-finals after brushing aside two-time Grand Slam champion Petra Kvitova in straight sets.

The 28-year-old eighth seed shrugged off a rain delay on the Arthur Ashe Stadium court to win 6-3, 6-2 and ease into a last eight meeting with either world number one Iga Swiatek.

Pegula, whose parents are

the billionaire owners of the Buffalo Bills NFL franchise, was always in control against out-of-sorts Czech veteran Kvitova, who had taken down Spain's Garbine Muguruza in the third round.

Pegula has reached quarter-finals at the Australian Open and French Open this season but had never gone further than the third round in five previous appearances at the US Open. She joins fellow American Coco Gauff in the last eight.

Pogba set for knee surgery, could miss WC

Paul Pogba's return to Juventus' training pitches was short-lived after tests determined the midfielder requires knee surgery.

The 29-year-old is therefore a huge doubt for France's defense of its World Cup crown this winter. Pogba played the first half of a preseason friendly against Chivas de Guadalajara after rejoining Juventus in July but has since been sidelined with a torn meniscus.

"I hope we get him back before the World Cup," Juventus head coach Massimiliano Allegri said on Monday, according to The Athletic's James Horncastle. "But ... the World Cup isn't my problem. Juve's problem is he comes back in January."

Allegri added on Pogba's latest setback: "This morning he trained for the second time, but then stopped, and it was then decided that he undergo surgery."

Pogba should take around 40-60 days to recover from meniscus surgery, according to multiple reports.

France's World Cup campaign kicks off against Australia on November 22. Juventus' final match before some of their players leave for the tournament in Qatar is Lazio's visit on November 13.

AP ■ MANCHESTER

Manchester City coach Pep Guardiola on Monday said the team cannot rely on Erling Haaland to single-handedly win them the Champions League this season following his remarkable start to life in England.

The Norway striker has scored 10 goals in his first six Premier League games since his £51 million (\$58 million) move from Borussia Dortmund this summer.

"All the players who come here were brought here by the club to make us better, that makes sense," said Guardiola ahead of Tuesday's opening group game away to Sevilla.

"If we rely on Erling's shoulders, we will not win the Champions League."

City reached the semi-finals of last season's competition before an astonishing comeback from Real Madrid cost them a shot at winning a first European title.



Haaland alone won't win CL for Manchester City: Guardiola

The Premier League champions have brought in England midfielder Calvin Phillips, Argentine striker Julian Alvarez and defenders Manuel Akanji and Sergio Gomez to strengthen the squad.

However the capture of Haaland was the headline deal, and one that Guardiola hopes can inspire City to the trophy in Istanbul next June.

"Hopefully, we can do it," said Guardiola.

"He came here because we convinced him. We didn't have strikers and he felt he could play with us."

"He has settled well, like with Julian and the other new players."

"I understand completely why everyone is talking about

Erling but I have six new players and I want them to settle as quickly as possible.

"We won't win just because of Erling but he has a special talent, and he can help us solve problems, definitely. But if we don't play well, we will not win."

City will be without defensive pair Kyle Walker and John Stones against Sevilla.

Walker limped off towards the end of Saturday's 1-1 draw with Aston Villa, while Stones also picked up a minor knock.

"(They are) injured. John is not much, Kyle is not much too, but I don't know if he will be ready for Saturday, or Dortmund or Wolves before the international break," said Guardiola.

HOJLUND FIRES ATALANTA PAST MONZA

Rasmus Hojlund helped move Atalanta two points clear at the top of Serie A on Monday after opening his account for the club in a 2-0 stroll against bottom side Monza.

Nanda Devi Mahotsav- A celebration of faith & culture

Since ancient times, Nanda Devi has been venerated in Uttarakhand as a tutelary goddess. The Naina Devi temple in Nainital is venerated by all devotees of the goddess. In this shrine the goddess is worshipped in the incarnation of Nav Durga. The present temple was established in 1883. Before that it was located near the Boat House but was destroyed in the devastating landslide of 1880. After the new temple was built in 1883, it continued to expand to its present condition. Now, a large number of people from across India and abroad come here to pay their obeisance to the goddess. Currently, the

120th Nanda Devi Mahotsav is currently underway in Nainital wherein sister goddesses Nanda and Sunanda are worshipped with fervour. The facial representations of goddesses Nanda and Sunanda are made from Kadli (plantain stems), bamboo and organic colours for this festival. For making the faces of the goddesses, the plantain is used to craft the outer appearance of the face. Bamboo is used to craft the eyebrows and also to nail the parts of the representation after which these are painted in attractive colours. After this, the faces are adorned with ornaments including a crown made of silver, a gold ornament for the forehead, earrings, nath (traditional nose ring) and other items. After that the idols are brought to the Naina Devi temple and ritually installed there. After being kept in the temple for the devotees to pay their obeisance, the representation of the goddesses are immersed in the Naini lake following a procession either attended or welcomed by most of the townsfolk.


